A bill to impose a specific tax on spirits; to provide for the collection of the tax; to prescribe certain powers and duties of the liquor control commission; to provide for the disposition of the tax; and to repeal this act on a specific date.

- 1 sold in the state, at the time of sale, a specific tax equal to
- 2 1% of the retail selling price of the spirits.
- 3 Sec. 3. Upon collection, the entire proceeds of the tax
- 4 collected under section 2 shall be deposited in the state trea-
- 5 sury to the credit of the drunk driver detention and correction
- 6 center fund.
- 7 Sec. 4. A licensee who on January 1, 1991 has on hand any
- 8 spirits shall file a complete inventory of those spirits with the
- 9 liquor control commission not later than January 31, 1992 and, at
- 10 the same time, remit to the commission a specific tax equal to 2%
- 11 of the retail selling price of the spirits. Upon receipt, the
