- 3 STATEMENT OR WITHHOLDS INFORMATION IN CONNECTION WITH THE SIGNED
- 4 STATEMENT REQUIRED UNDER SECTION 34B IS GUILTY OF A MISDEMEANOR,
- 5 PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 6 MONTHS OR A FINE
- 6 OF NOT MORE THAN \$1,000.00, OR BOTH.
