- 4 SEC. 112A. (1) THE BETTER BEGINNINGS PROGRAM IS ESTABLISHED
- 5 IN THE STATE DEPARTMENT TO PROVIDE MEDICAL SERVICES TO CHILDREN
- 6 OF 18 YEARS OF AGE OR LESS IN CERTAIN HOUSEHOLDS THAT ARE INELI-
- 7 GIBLE FOR MEDICAID.

- 1 (2) THE STATE DEPARTMENT SHALL PROVIDE MEDICAL SERVICES
- 2 UNDER THE BETTER BEGINNINGS PROGRAM TO A CHILD WHO IS BOTH OF THE

- 2 ESTABLISHED AND OPERATED PURSUANT TO SECTION 105.
- 3 (B) "POVERTY LEVEL" MEANS THE OFFICIAL POVERTY LEVEL ESTAB-
- 4 LISHED BY THE FEDERAL GOVERNMENT.
