## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 3 Compiled Laws, is amended by adding part 105 to read as follows:

- 5 SEC. 10501. AS USED IN THIS PART:
- 6 (A) "EMPLOYEE" MEANS A PERSON OTHER THAN AN INDEPENDENT CON-
- 7 TRACTOR WHO PERFORMS SERVICES FOR HIRE FOR AN EMPLOYER, FOR AN
- 8 AVERAGE OF 20 OR MORE HOURS PER WEEK.

- 1 (B) "EMPLOYER" MEANS A PERSON OR GOVERNMENTAL ENTITY THAT
- 2 EMPLOYS AN EMPLOYEE.
- 3 (C) "FUND" MEANS THE STATE EMPLOYEE BONE MARROW DRIVE FUND
- 4 CREATED IN SECTION 10505.
- 5 (D) "STATE EMPLOYEE" MEANS AN EMPLOYEE OF THE STATE OF
- 6 MICHIGAN.

- 15 (i) THE NEED FOR BONE MARROW DONORS IN THIS STATE.

- 26 (C) DEVELOP AND PUBLISH A PAMPHLET THAT CONTAINS THE
- 27 INFORMATION DESCRIBED IN SUBDIVISION (B).

- 1 (2) IN DEVELOPING THE EDUCATIONAL PROGRAM DESCRIBED IN
- 2 SUBSECTION (1), THE DEPARTMENT SHALL DO THE FOLLOWING:
- 3 (A) ENCOURAGE MINORITY POPULATIONS TO BECOME BONE MARROW
- 4 DONORS.
- 5 (B) WITHIN 1 YEAR OF THE EFFECTIVE DATE OF THE AMENDATORY
- 6 ACT THAT ADDED THIS PART, PROVIDE THE SECRETARY OF STATE WITH A
- 7 BONE MARROW DONOR INFORMATIONAL PAMPHLET DEVELOPED UNDER THIS
- 8 PART, FOR DISTRIBUTION BY THE SECRETARY OF STATE PURSUANT TO SEC-
- 9 TION 310 OF THE MICHIGAN VEHICLE CODE, ACT NO. 300 OF THE PUBLIC
- 10 ACTS OF 1949, BEING SECTION 257.310 OF THE MICHIGAN COMPILED
- 11 LAWS.
- 12 (C) PUBLICIZE THE BONE MARROW REGISTRY AND THE NEED FOR BONE
- 13 MARROW DONORS THROUGH THE USE OF ANY MEDIUM THAT THE DEPARTMENT
- 14 DETERMINES APPROPRIATE.
- 15 (3) WITHIN 1 YEAR OF THE EFFECTIVE DATE OF THE AMENDATORY
- 16 ACT THAT ADDED THIS PART, THE DEPARTMENT SHALL CONDUCT A BONE
- 17 MARROW DONOR DRIVE DIRECTED AT STATE EMPLOYEES, AND SHALL MAKE
- 18 AVAILABLE TO STATE EMPLOYEES THE INFORMATION DESCRIBED IN SUBSEC-
- 19 TION (1) AND EDUCATIONAL MATERIALS FURNISHED BY THE NATIONAL BONE
- 20 MARROW DONOR PROGRAM THAT ARE APPROVED BY THE DEPARTMENT.
- 21 SEC. 10505. (1) THE STATE EMPLOYEE BONE MARROW DRIVE FUND
- 22 IS CREATED WITHIN THE DEPARTMENT OF TREASURY AND SHALL BE ADMIN-
- 23 ISTERED BY THE DEPARTMENT OF PUBLIC HEALTH. THE FUND IS CAPITAL-
- 24 IZED BY GRANTS FROM THE NATIONAL MARROW DONOR PROGRAM. THE FUND
- 25 MAY ADDITIONALLY RECEIVE MONEY AS PROVIDED IN THIS PART AND AS
- 26 OTHERWISE PROVIDED BY LAW, AND SHALL RECEIVE ANY GIFTS OR
- 27 CONTRIBUTIONS TO THE FUND. DONATIONS MADE TO THE FUND ARE TAX

- 1 DEDUCTIBLE UNDER THE NONPROFIT DESIGNATION GIVEN TO THE NATIONAL
- 2 MARROW DONOR PROGRAM UNDER SECTION 501(c)(3) OF THE INTERNAL REV-
- 3 ENUE CODE.
- 4 (2) THE STATE TREASURER SHALL CREDIT TO THE FUND INTEREST
- 5 AND EARNINGS OF THE FUND. THE STATE TREASURER SHALL RETAIN THE
- 6 MONEY IN THE FUND AT THE CLOSE OF THE FISCAL YEAR AND SHALL NOT
- 7 CONVEY THAT MONEY TO THE GENERAL FUND.
- 8 (3) THE DEPARTMENT SHALL EXPEND MONEY IN THE FUND ONLY TO
- 9 PAY FOR THE STATE EMPLOYEE BONE MARROW DRIVE DESCRIBED IN SECTION
- 10 10503(3).
- 11 SEC. 10507. (1) AN EMPLOYER SHALL NOT DENY AN EMPLOYEE A
- 12 VESTED PAID LEAVE OF ABSENCE FOR THAT EMPLOYEE'S DONATION OF BONE
- 13 MARROW. UNLESS AN EMPLOYER AGREES TO A GREATER PERIOD OF TIME,
- 14 AN EMPLOYEE'S PAID LEAVE OF ABSENCE FOR A BONE MARROW DONATION
- 15 SHALL BE FOR A PERIOD THAT IS THE LESSER OF THE FOLLOWING:
- 16 (A) THE TOTAL AMOUNT OF THAT EMPLOYEE'S VESTED PAID LEAVE OF
- 17 ABSENCE, OR A LESSER PERIOD DETERMINED BY THE EMPLOYEE.
- 18 (B) FORTY WORKING HOURS, OR A LESSER PERIOD DETERMINED BY
- 19 THE EMPLOYEE.
- 20 (2) AN EMPLOYER MAY REQUIRE A PHYSICIAN'S VERIFICATION OF
- 21 THE PURPOSE AND DURATION OF EACH LEAVE OF ABSENCE AN EMPLOYEE
- 22 REQUESTS FOR A BONE MARROW DONATION. A PHYSICIAN'S DETERMINATION
- 23 THAT AN EMPLOYEE IS NOT QUALIFIED AS A BONE MARROW DONOR DOES NOT
- 24 AFFECT A LEAVE OF ABSENCE FOR A BONE MARROW TRANSPLANT TAKEN BY
- 25 THAT EMPLOYEE BEFORE THE PHYSICIAN'S DETERMINATION.

- 1 (3) AN EMPLOYER SHALL NOT RETALIATE AGAINST AN EMPLOYEE FOR
- 2 THAT EMPLOYEE'S REQUEST FOR OR USE OF A VESTED PAID LEAVE OF
- 3 ABSENCE TO DONATE BONE MARROW.
- 4 (4) AN EMPLOYER MAY PROVIDE A PAID LEAVE OF ABSENCE FOR A
- 5 BONE MARROW DONATION THAT IS OF A GREATER DURATION THAN THE
- 6 PERIOD DESCRIBED IN SUBSECTION (1).
- (5) THIS PART DOES NOT AFFECT AN EMPLOYEE'S BENEFIT THAT IS 7
- 8 NOT DESCRIBED IN THIS PART.
