A bill to create the Michigan national guard scholarship grant program, to provide financial aid for certain individuals at Michigan colleges and universities; to prescribe certain powers and duties of certain state agencies; and for related purposes.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. This act shall be known and may be cited as the
- 2 "Michigan national guard scholarship act".
- 3 Sec. 2. As used in this act:
- 4 (a) "Authority" means the Michigan higher education assist-
- 5 ance authority created by Act No. 77 of the Public Acts of 1960,
- 6 being sections 390.951 to 390.961 of the Michigan Compiled Laws.
- 7 (b) "Grant" means a first-year Michigan national guard
- 8 scholarship grant or a renewal of a Michigan national guard
- 9 scholarship grant.

- 1 (c) "Michigan college or university" means a state
- 2 university described in section 4, 5, or 6 of article VIII of the
- 3 state constitution of 1963; a community or junior college estab-
- 4 lished under section 7 of article VIII of the state constitution
- 5 of 1963 or part 25 of the school code of 1976, Act No. 451 of the
- 6 Public Acts of 1976, being sections 380.1601 to 380.1607 of the
- 7 Michigan Compiled Laws; or a regionally accredited nonprofit
- 8 independent degree-granting college or university that is located
- 9 in this state and recognized by the state board of education.
- (d) "Tuition" means the tuition and mandatory fees charged
- 11 by a Michigan college or university to a Michigan resident.
- 12 Sec. 3. (1) The Michigan national guard scholarship program
- 13 is created, to be administered by the authority.
- 14 (2) The authority shall do all of the following:
- 15 (a) Determine the eligibility of applicants.
- (b) Pay to Michigan colleges and universities on behalf of
- 17 grant recipients the difference between the grant recipient's
- 18 tuition and the amounts received by the grant recipient or by the
- 19 public college or university on behalf of the grant recipient
- 20 from the other financial aid sources described in section
- 21 4(1)(i). However, if the grant recipient is enrolled in an inde-
- 22 pendent college or university that is a Michigan college or uni-
- 23 versity, the amount to be paid to the independent college or uni-
- 24 versity shall be calculated using either the prevailing average
- 25 full-time tuition cost of the public universities in this state
- 26 or the grant recipient's tuition, whichever is less. Prorated
- 27 payments shall be made at the beginning of each semester or term

- 1 to the Michigan college or university to the student's account.
- 2 Payment shall be made only for classes that are taken for credit
- 3 and that apply toward the requirements for a degree or
- 4 certificate.
- 5 (c) Promulgate rules it considers necessary for the adminis-
- 6 tration of this act. The rules shall be promulgated under the
- 7 administrative procedures act of 1969, Act No. 306 of the Public
- 8 Acts of 1969, being sections 24.201 to 24.328 of the Michigan
- 9 Compiled Laws.
- 10 Sec. 4. (1) An individual is eligible to receive a
- 11 first-year Michigan national guard scholarship grant under this
- 12 act if he or she is determined by the authority to meet all of
- 13 the following requirements:
- (a) Has resided continuously in this state for the immedi-
- 15 ately preceding 12 months and is not considered a resident of any
- 16 other state.
- (b) Is not incarcerated in a corrections institution.
- (c) Is a United States citizen or permanent resident.
- (d) Is not enrolled in a program leading to a degree in the-
- 20 ology, divinity, or religious education.
- 21 (e) Is not in default on a loan guaranteed by the
- 22 authority.
- (f) Has complied with this act and rules promulgated under
- 24 this act.
- 25 (g) Is admitted to and enrolls in a Michigan college or
- 26 university.

- 1 (h) Submits to the authority a certificate of eligibility
 2 issued by the Michigan national guard certifying that he or she
 3 meets 1 or more of the following:
- 4 (i) Is an active member of the Michigan national guard hold-5 ing a rank not higher than captain who has entered into a commit-6 ment to remain a member for at least 6 years and has served for

- 8 (ii) Is the surviving spouse or child of a member of the
 9 Michigan national guard who died as the direct and proximate
 10 result of a traumatic injury or of a disease caused by or result11 ing from a traumatic injury incurred while the member was per12 forming an act he or she was obligated to perform in the active
- (i) Applies at the appropriate time for other financial aid

 15 that is available from the state or federal government or from

 16 the Michigan college or university in the form of a grant or

 17 scholarship, and accepts the financial aid. The individual is

 18 not required to apply for or accept an educational loan.
- (2) An individual is eligible to receive a renewal of a

 20 Michigan national guard scholarship grant under this act for the

 21 period specified in subsection (3) if he or she is determined by

 22 the authority to continue to meet all of the requirements of sub
 23 section (1) and to meet all of the following requirements:
- (a) Maintains satisfactory academic progress at the Michigancollege or university in which he or she is enrolled, as definedby the Michigan college or university.

- (b) Maintains satisfactory performance with the Michigan
 national quard.
- 3 (3) A grant recipient is eligible for a renewal of a
- 4 Michigan national guard scholarship grant for the following time
- 5 periods:
- 6 (a) For an individual qualifying under subsection (1)(h)(i),
- 7 10 years from the date he or she initially receives a grant.
- 8 (b) For an individual qualifying under subsection (1)(h)(ii)
- 9 as a surviving spouse, 10 years from the date of the Michigan
- 10 national guard member's death, but not after completing the
- 11 degree requirements for a bachelor's degree.
- (c) For an individual qualifying under subsection (1)(h)(ii)
- 13 as a surviving child, until the individual's twenty-fifth birth-
- 14 day, but not after completing the degree requirements for a
- 15 bachelor's degree.
- 16 Sec. 5. Upon application, the adjutant general of the
- 17 Michigan national guard or his or her designee shall issue cer-
- 18 tificates of eligibility to individuals it determines to meet the
- 19 requirements specified in section 4(1)(h) or 4(2)(b).
- 20 Sec. 6. (1) If a member of the Michigan national guard
- 21 receiving a grant under this act voluntarily withdraws from a
- 22 course for which he or she has received the grant and the author-
- 23 ity does not receive a refund from the college or university, the
- 24 member shall reimburse the authority for the amount of the grant
- 25 attributable to that course.
- 26 (2) If a member of the Michigan national guard receiving a
- 27 grant under this act fails to complete his or her term of

- 1 enlistment for a reason other than death or disability, the
- 2 member shall reimburse the authority for the amount of the grants
- 3 he or she received.
- 4 (3) If a member of the Michigan national guard receiving a
- 5 grant or grants under this act becomes obligated under
- 6 subsection (1) or (2) to reimburse the authority for the amount
- 7 of the grants he or she received, the grants he or she received
- 8 shall become a loan repayable to the authority at the same inter-
- 9 est rate and on the same terms and conditions as a loan guaran-
- 10 teed by the authority under Act No. 77 of the Public Acts of
- 11 1960, being sections 390.951 to 390.961 of the Michigan Compiled
- 12 Laws. The authority shall enforce repayment of the loan in the
- 13 same manner as it enforces repayment of a loan guaranteed by the
- 14 authority under Act No. 77 of the Public Acts of 1960.
