"Michigan vehicle code,"

being section 257.653 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 653 of Act No. 300 of the Public Acts of
- 2 1949, being section 257.653 of the Michigan Compiled Laws, is
- 3 amended to read as follows:
- Sec. 653. (1) Upon the immediate approach of an authorized
- 5 emergency vehicle equipped with not less than 1 lighted flashing,
- 6 rotating, or oscillating lamp exhibiting a red or blue light vis-
- 7 ible under normal atmospheric condition from a distance of 500
- 8 feet to the front of the vehicle and when the driver is giving
- 9 audible signal by siren, exhaust whistle, or bell:

- 1 (a) The driver of another vehicle shall yield the right of
- 2 way and shall immediately drive to a position parallel to and as
- 3 close as possible to the right-hand edge or curb of the roadway,
- 4 clear of an intersection, and shall stop and remain in that posi-
- 5 tion until the authorized emergency vehicle has passed, except
- 6 when otherwise directed by a police officer.
- 7 (b) The operator of a streetcar shall immediately stop the
- 8 car, clear of an intersection, and shall keep it in that position
- 9 until the authorized emergency vehicle has passed, except when
- 10 otherwise directed by a police officer.
- 11 (2) IN A PROCEEDING FOR A VIOLATION OF SUBSECTION (1), PROOF
- 12 THAT THE PARTICULAR VEHICLE DESCRIBED IN THE CITATION WAS IN VIO-
- 13 LATION OF SUBSECTION (1), TOGETHER WITH PROOF THAT THE DEFENDANT
- 14 NAMED IN THE CITATION WAS, AT THE TIME OF THE VIOLATION, THE REG-
- 15 ISTERED OWNER OF THE VEHICLE, SHALL CONSTITUTE IN EVIDENCE A PRE-
- 16 SUMPTION THAT THE REGISTERED OWNER OF THE VEHICLE WAS THE DRIVER
- 17 OF THE VEHICLE AT THE TIME OF THE VIOLATION.
- 18 (3) $\frac{(2)}{}$ This section does not relieve the driver of an
- 19 authorized emergency vehicle from the duty to drive with due
- 20 regard for the safety of persons using the highway.
- 21 (4) -(3) A person who violates this section is -responsible
- 22 for a civil infraction GUILTY OF A MISDEMEANOR.
