- 5 of the employee's compensation arrangement, the board of a school
- 6 district may purchase an annuity contract A TAX-DEFERRED
- 7 INVESTMENT for an employee for retirement or other purposes and
- 8 may make payroll allocations in accordance with the arrangement
- 9 for the purpose of paying the entire premium to become due under
- 10 the annuity contract TO PAY FOR THE TAX-DEFERRED INVESTMENT.

- 1 The allocation shall be made in a manner which will qualify -the
- 2 annuity premiums, or a portion thereof, ALL OF PART OF THE
