- 1 Section 1. Section 1 of Act No. 469 of the Public Acts of

- 4 Sec. 1. As used in this act:
- 5 (a) "Employee" means a person who performs a service for
- 6 wages or other remuneration under a contract of hire, written or
- 7 oral, express or implied. Employee includes a person employed by
- 8 the state or a political subdivision of the state. -except state
- 9 classified civil service.

- (b) "Employer" means a person who has 1 or more employees.
- 2 Employer includes an agent of an employer and the state or a
- 3 political subdivision of the state.
- 4 (c) "Person" means an individual, sole proprietorship, part-
- 5 nership, corporation, association, or any other legal entity.
- 6 (d) "Public body" means all of the following:
- 7 (i) A state officer, employee, agency, department, division,
- 8 bureau, board, commission, council, authority, or other body in
- 9 the executive branch of state government.
- 10 (ii) An agency, board, commission, council, member, or
- 11 employee of the legislative branch of state government.
