- 1 Section 1. Section 2608 of Act No. 218 of the Public Acts
 2 of 1956, being section 500.2608 of the Michigan Compiled Laws, is
 3 amended to read as follows:
- Sec. 2608. (1) The commissioner shall review filings as 5 soon as reasonably possible after they have been made in order to 6 determine whether they meet the requirements of this chapter.
- 7 (2) Subject to the exception specified in subsection (3) of 8 this section, each EACH filing shall be on file for a waiting 9 period of 15 days before it becomes effective, which period may 10 be extended by the commissioner for an additional period not to

- 1 exceed 15 days if the THE COMMISSIONER gives written notice
- 2 within -such THE waiting period to the insurer or rating organi-
- 3 zation -which- THAT made the filing that he OR SHE needs such
