HOUSE BILL No. 5363

December 3, 1991, Introduced by Rep. Porreca and referred to the Committee on Towns and Counties.

A bill to amend the title of Act No. 160 of the Public Acts of 1974, entitled

"An act to provide for the adjustment of county boundaries; to provide for referendum thereon; and to prescribe the powers and duties of the secretary of state,"

being sections 45.101 and 45.102 of the Michigan Compiled Laws; and to add sections 3 and 4.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. The title of Act No. 160 of the Public Acts of

- 10 ROAD AND CONTINUING ALONG THE MIDLINE OF VAN BORN ROAD TO THE
- 11 WAYNE COUNTY BOUNDARY WITH WASHTENAW COUNTY, IS FILED WITH THE
- 12 COUNTY CLERK OF WAYNE COUNTY, THE QUESTION OF ESTABLISHING ERIE
- 13 COUNTY SHALL BE PLACED ON THE BALLOT AT THE NEXT GENERAL NOVEMBER
- 14 ELECTION TO BE HELD NOT LESS THAN 90 DAYS AFTER THE DATE THE
- 15 PETITION IS FILED. IF A MAJORITY OF THE ELECTORS RESIDING WITHIN
- 16 THE BOUNDARIES OF THE PROPOSED ERIE COUNTY VOTING ON THE OUESTION
- 17 AND A MAJORITY OF THE ELECTORS RESIDING WITHIN THE BALANCE OF

- 21 SEC. 4. (1) AT A NONPARTISAN SPECIAL ELECTION TO BE HELD 1
- 22 YEAR AFTER THE ELECTION PROVIDED FOR IN SECTION 3, A CHARTER COM-
- 23 MISSION OF 5 MEMBERS SHALL BE ELECTED AT LARGE BY ELECTORS RESID-
- 24 ING WITHIN THE BOUNDARIES OF THE PROPOSED ERIE COUNTY FOR TERMS
- 25 TO BEGIN ON THE JANUARY 1 IMMEDIATELY FOLLOWING THEIR ELECTION.
- 26 AFTER THE DECEMBER 31 IMMEDIATELY FOLLOWING THE ELECTION OF THE
- 27 CHARTER COMMISSION, MEMBERS OF THE COUNTY BOARD OF COMMISSIONERS

- 1 OF WAYNE COUNTY WHOSE DISTRICTS LIE WITHIN THE BOUNDARIES OF THE
- 2 PROPOSED ERIE COUNTY SHALL NO LONGER SERVE ON THE COUNTY BOARD OF
- 3 COMMISSIONERS OF WAYNE COUNTY.
- (2) THE CHARTER COMMISSION SHALL DO ALL OF THE FOLLOWING:

- (D) PROVIDE FOR ALL OTHER MATTERS NECESSARY OR DESIRABLE FOR 10

- 12 (3) THE CHARTER COMMISSION MAY ADJUST THE BOUNDARIES OF ERIE
- 13 COUNTY PROVIDED FOR IN SECTION 3.
