THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 1249 of Act No. 451 of the Public Acts
- 2 of 1976, as added by Act No. 232 of the Public Acts of 1988,
- 3 being section 380.1249 of the Michigan Compiled Laws, is amended
- 4 to read as follows:
- 5 Sec. 1249. (1) The board of a school district or intermedi-
- 6 ate school district shall provide that each secondary school
- 7 teacher in the district may review a copy of the official
- 8 transcript of each pupil the teacher taught.

- 1 (2) The board of a school district or intermediate school
- 2 district shall not permit any board member, superintendent,
- 3 assistant superintendent, principal, assistant principal, quid-
- 4 ance director, teacher, or any other person to change a grade
- 5 given to a pupil by a teacher unless 1 of the following occurs:
- 6 (a) The teacher who gave a grade to the pupil is informed of
- 7 1 or more reasons why the grade should be changed and the teacher
- 8 concurs in the grade change.
- 9 (b) If a teacher who gave a grade to the pupil does not
- 10 concur in the grade change, a majority of a review panel, after
- 11 evaluating the reasons for a requested grade change, approves the
- 12 grade change and the INVOLVED teacher, -involved PUPIL, OR A
- 13 PARENT OR LEGAL GUARDIAN ON BEHALF OF THE PUPIL does not appeal
- 14 the panel's decision. The panel described in this subdivision
- 15 shall be composed of 3 teachers selected by their bargaining
- 16 unit, 1 board member, and the superintendent of schools or the
- 17 superintendent's designee.
- 18 (c) If the INVOLVED teacher, involved PUPIL, OR PARENT OR
- 19 LEGAL GUARDIAN ON BEHALF OF THE PUPIL appeals the decision of the
- 20 review panel described in subdivision (b) to the board, and a
- 21 majority of the board members elected and serving approve the
- 22 grade change at a meeting of the board at which the reasons for
- 23 changing the grade are reviewed. A decision of the board on the
- 24 merits of the grade change -shall be- IS final.
- 25 (3) A pupil shall be informed of a grade change made pursu-
- 26 ant to this section.

- 1 (4) A board review of a grade change provided for in
- 2 subsection (2)(c) shall comply with section 438 of subpart 2 of
- 3 part c of the general education provisions act, title IV of
- 4 Public Law 90-247, 20 U.S.C. 1232g, commonly referred to as the
- 5 family educational rights and privacy act of 1974.
- 6 (5) The board of a school district or intermediate school
- 7 district shall establish a disciplinary procedure -which THAT
- 8 shall be enforced -when IF a person violates the grade changing
- 9 procedure described in this section.
