

HOUSE BILL No. 5411

A bill to amend section 1 of Act No. 291 of the Public Acts of 1967, entitled

"An act to authorize state universities and colleges to enact parking, traffic and pedestrian ordinances and to provide for the enforcement of the ordinances; and to dispose of fines collected,"

being section 390.891 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Section 1 of Act No. 291 of the Public Acts of
2 1967, being section 390.891 of the Michigan Compiled Laws, is
3 amended to read as follows:

4 Sec. 1. The governing boards of state universities and
5 colleges may each enact parking, traffic, and pedestrian ordi-
6 nances for the government and control of their respective
7 campuses. If an ordinance is enacted, the governing board shall
8 specify whether a particular violation is a misdemeanor or a

1 civil infraction. Enforcement of the ordinance shall be by law
2 enforcement officers of this state or the county, township, or
3 city where the violation of the ordinance occurs. THE GOVERNING
4 BOARD OF A STATE UNIVERSITY OR COLLEGE MAY AUTHORIZE A PERSON
5 OTHER THAN A LAW ENFORCEMENT OFFICER TO ISSUE AND SERVE A
6 CITATION FOR A VIOLATION OF THE ORDINANCE PERTAINING TO HANDICAP-
7 PER PARKING IF THE GOVERNING BOARD COMPLIES WITH THE REQUIREMENTS
8 OF SECTION 675D OF THE MICHIGAN VEHICLE CODE, ACT NO. 300 OF THE
9 PUBLIC ACTS OF 1949, BEING SECTION 257.675D OF THE MICHIGAN
10 COMPILED LAWS. The ordinance shall be in substantial conformity
11 with the uniform traffic code promulgated pursuant to Act No. 62
12 of the Public Acts of 1956, being sections 257.951 to 257.954 of
13 the Michigan Compiled Laws.

14 Section 2. This amendatory act shall not take effect unless
15 Senate Bill No. _____ or House Bill No. 5412 (request
16 no. 03561'91a) of the 86th Legislature is enacted into law.
