- 1 PROVISIONS OF LAW OR CHARTER IN ORDER TO BECOME A PARTICIPATING

- 3 (2) UPON RECEIPT OF A PETITION UNDER SUBSECTION (1), THE
- 4 RETIREMENT BOARD SHALL APPROVE OR DISAPPROVE THE PETITION TO
- 5 BECOME A PARTICIPATING MUNICIPALITY AND TO TRANSFER A PREEXISTING

- 1 RETIREMENT ALLOWANCE PAYABLE TO A RETIRANT OR BENEFICIARY SHALL
- 2 NOT BE DIMINISHED OR IMPAIRED BY REASON OF THE TRANSFER.
