HOUSE BILL No. 5509

February 18, 1992, Introduced by Reps. Willis Bullard, Munsell, Dobb and Middleton and referred to the Committee on State Affairs.

A bill to authorize the department of natural resources to convey certain state owned property in Livingston and Oakland counties; to prescribe conditions for the conveyance; and to provide for disposition of the revenue derived from the conveyance.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 1. The department of natural resources, on behalf of
- 2 the state, may convey to the township of Rose, for consideration
- 3 of \$1.00, certain real property under the jurisdiction of the
- 4 department of natural resources and located in the county of
- 5 Oakland and the county of Livingston, Michigan, and more particu-
- 6 larly described as:
- 7 A parcel of land described as beginning at the Southwest
- 8 corner of Section 6, thence Northerly along the West section
- 9 line, a distance of 1,655.3 feet, thence North 89° 34' East 270
- 10 feet, North 50° 08' East 326 feet, South 88° 50' East 236.3 feet,

- 1 South 28° 34' East 226.7 feet, Easterly to the North South 1/8
- 2 line, a distance of 251.6 feet, South along the West 1/8 line to
- 3 the South line of Section 6, Westerly to the West line of Section
- 4 6 to point of beginning, excepting that part of Southwest quarter
- 5 of Southwest fractional quarter lying Southwesterly of Tipsico
- 6 Lake Road, Rose Township, Township 4 North, Range 7 East, Oakland
- 7 County, Michigan,
- B ALSO: Part of the Southeast quarter of Section 1 described
- 9 as beginning at a point on the East line of said section, 131.6
- 10 feet North of the Southeast corner of the section, thence North
- 11 along the section line 490.8 feet, South 48° 00' West 316.9 feet;
- 12 South 40° 06' East 364.3 feet to the point of beginning, Tyrone
- 13 Township, Township 4 North, Range 6 East, Livingston County,
- 14 Michigan.
- 15 Sec. 2. Subject to section 3, the conveyance authorized by
- 16 this act shall provide that the property shall be used only for
- 17 public recreation purposes and that the property shall be open to
- 18 all residents of the state on the same terms, fees, and condi-
- 19 tions; and that upon termination of that use or upon use of any
- 20 other purpose, title to the property shall revert immediately to
- 21 the state, with the state assuming no liability for any improve-
- 22 ments made by the township of Rose or by any other party.
- Sec. 3. The conveyance authorized by this act shall provide
- 24 that the township of Rose is authorized to sell to adjacent prop-
- 25 erty owners certain parcels of property that are within the
- 26 parcel described in section 1 and are located south of Baker
- 27 road. The conveyance also shall provide that if the township

- 1 conveys any of that property, the township shall reimburse the
 2 state for the fair market value of the property.
- 3 Sec. 4. The conveyance authorized by this act shall be by
- 4 quitclaim deed approved by the attorney general and shall reserve
- 5 to the state all rights to coal, oil, gas, and other nonmetallic
- 6 minerals found on, within, or under the conveyed property.
- 7 Sec. 5. The revenue received under this act shall be depos-
- 8 ited in a restricted account held by the department of natural
- 9 resources.
