HOUSE BILL No. 5515

EXECUTIVE BUDGET BILL

February 18, 1992, Introduced by Reps. Ostling, Oxender, Bender and Allen and referred to the Committee on Appropriations.

A bill to make appropriations for the department of state police, and certain other state purposes for the fiscal year ending September 30, 1993; to provide for the expenditure of those appropriations; to provide for certain reports and the consideration of those reports; to provide for the disposition of other income received by the various state agencies; to provide testing of certain persons; to provide for certain emergency powers; and to provide for the powers and duties of certain committees, certain state agencies, and certain employees.

- (2) When it appears to the principal executive officer of each 10 department that state spending to local units of government will be less 11 than the amount that was projected to be expended for any quarter, the 12 principal executive officer shall immediately give notice of the 13 approximate shortfall to the department of management and budget, the 14 senate and house appropriations committees, and the senate and house 15 fiscal agencies.
- Sec. 202. The appropriations made and the expenditures authorized 16 17 under this act and the departments, agencies, commissions, boards, 18 offices, and programs for which an appropriation is made under this act 19 are subject to the management and budget act, Act No. 431 of the Public 20 Acts of 1984, being sections 18.1101 to 18.1594 of the Michigan Compiled 21 Laws.
- 22 Sec. 203. As used in this act:
- 23 (a) "AFIS" means automated fingerprint identification system.
- 24 (b) "AIS/ICF/MR" means alternate intermediate 25 intermediate care facilities, mentally retarded.
- 26 (c) "CARE" means combined accident reduction effort.
- "CCD" or "consolidated central dispatch" means an entity 27 (d) 28 consisting of 75% or more of the law enforcement, fire fighting, and

1 emergency service agencies, or those agencies encompassing 75% or more 2 of the population of the service area, joined under a written agreement 3 to operate under a single dispatching operation. The 75% requirements 4 for a CCD may be waived in counties of over 250,000 where other 5 configurations promise effective and efficient services. A CCD must also 6 include all of the following: The participation of the county sheriff 7 and the state police. The control of central dispatching by a countywide 8 or regional authority consisting of representatives of participating 9 jurisdictions and agencies and the general public, that selects 10 supervisory staff and oversees operations. One or 2 dispatching points 11 operated by the authority as is determined to be necessary given the size 12 of the county. Dispatch services 24 hours a day, 7 days a week, 13 year-round to all participating jurisdictions and agencies. A written 14 agreement including an annual budget by the participants that specifies 15 the nature and amount of service and identifies sources of financing, 16 including the provision of personnel, equipment, supplies, and funds from 17 participants or from dedicated sources. An operational policy based on 18 the concept of the dispatch of the closest unit, of the appropriate type, 19 to the service request. Operation using 9-1-1, or enhanced 9-1-1, under 20 the emergency telephone service enabling act, Act No. 32 of the Public 21 Acts of 1986, as amended, being sections 484.1101 to 484.1707, as 22 amended, of the Michigan Compiled Laws, where feasible and 23 cost-effective.

- 24 (e) "CCH" means computerized criminal history.
- 25 (f) "Department" means the department of state police.
- 26 (g) "DMB" means the Michigan department of management and budget.
- 27 (h) "DOD" means United States department of defense.
- 28 (i) "DOJ" means the United States department of justice.

- 1 (j) "DOJ-BJS" means the United States department of justice, 2 bureau of justice statistics.
- 3 (k) "DOT" means the United States department of transportation.
- 4 (1) "DOT-NHTSA" means DOT-national highway traffic safety 5 administration.
- 6 (m) "FTE" means full-time equated.
- 7 (n) "IDG" means interdepartmental grant.
- 8 (o) "IDT" means intradepartmental transfer.
- 9 (p) "LEIN" means law enforcement information network.
- 10 (q) "MDOT" means Michigan department of transportation.
- 11 (r) "MDOT-TSF" means Michigan department of transportation truck 12 safety fund.
- 13 (s) "MLEOTC" means the Michigan law enforcement officers training 14 council.
- 15 (t) "OHSP" means office of highway safety planning.
- 16 (u) "Title XVIII" means title XVIII of the social security act 17 of 1935, as amended.
- Sec. 204. The amounts appropriated for utilities and that portion 19 of contractual services, supplies, and materials used to pay for utility 20 service to state facilities in section 101 may be expended in a manner 21 consistent with section 253 of the management and budget act, Act No. 431 22 of the Public Acts of 1984, being section 18.1253 of the Michigan 23 Compiled Laws.
- Sec. 205. (1) Beginning October 1, 1992, there shall be a hiring 25 freeze imposed on the state classified civil service. State departments 26 and agencies shall be prohibited from hiring any new full-time state 27 classified civil service employees or prohibited from filling any vacant 28 state classified civil service positions. This hiring freeze does not

- 1 apply to internal transfers of classified employees from one position to 2 another within a department.
- 3 (2) The director of the department of management and budget shall 4 grant exceptions to this hiring freeze when the director believes that 5 such a hiring freeze will result in rendering a state department or 6 agency unable to deliver basic services, cause loss of revenue to the 7 state, result in the inability of the state to receive and expend federal 8 funds, or necessitate additional expenditures that exceed any savings 9 from maintaining a vacancy.

10 DEPARTMENTWIDE APPROPRIATIONS

- 11 Sec. 301. The department may receive and expend federal grant 12 awards, private donations, gifts, and bequests for support of 13 departmental activities, and may receive and expend funds pursuant to 14 agreements with local units of government, other state agencies, and 15 private organizations.
- Sec. 302. Money shall not be expended by the department to hire 17 or train an applicant for employment by the department unless that 18 applicant agrees in writing to submit to a controlled substance test that 19 is supervised by the department.

20 CRIMINAL JUSTICE DATA CENTER

- Sec. 401. In addition to the funds appropriated in section 101, 22 the department may receive funds from local units of government for the 23 purpose of expanding or upgrading the law enforcement information 24 network, if the funds do not require state money for matching purposes, 25 or for continuing programs if the funds from local units of government 26 become unavailable.
- Sec. 402. The \$1,897,200.00 appropriated in section 101 for a new 28 computer shall be used for the purchase, installation, and contract

1 maintenance of a new mainframe computer which shall be funded by LEIN 2 user fees sufficient to pay 1/3 of the purchase, installation, and 3 contract maintenance costs.

- Sec. 403. For the fiscal year ending September 30, 1993, the 5 department, in conjunction with the departments of social services, 6 transportation, secretary of state, and management and budget, shall 7 determine a cost of maintaining the traffic accident records program 8 based on each department's respective use, and shall enter into written 9 contracts requiring each department to pay its prorated share for using 10 that program.
- Sec. 404. (1) The state budget director is authorized to make 12 administrative transfers of the unexpended general fund-general purpose 13 amounts available from amounts appropriated in section 101 to special 14 work project accounts for office automation in the department.
- 15 (2) The office automation project:
- 16 (a) Proposes to replace and enhance existing department owned micro
 17 computers and to network that equipment with the department mainframe
 18 computer.
- 19 (b) Will identify old equipment with a history of maintenance 20 problems and equipment that is no longer capable of performing user 21 needs.
- 22 (c) Is estimated to cost not more than \$1,500,000.00.
- 23 (d) The department shall certify to the department of management 24 and budget by December 1, 1993 projected unexpended account balances 25 available for transfer pursuant to subsection (1).
- Sec. 405. (1) The funds appropriated in section 101 for the 27 automated fingerprint identification system shall be considered a work 28 project account that shall not lapse at the end of the fiscal year.

- 1 (2) In addition to funds appropriated under section 101, the 2 department may receive and expend funds from local units of government 3 pursuant to section 7 of A.F.I.S. policy council act, Act No. 307 of the 4 Public Acts of 1988, being section 28.157 of the Michigan Compiled Laws, 5 for the purpose of acquiring equipment for the automated fingerprint 6 identification system.
- Sec. 406. (1) The funds appropriated in section 101 include funds 8 for the purchase of AFIS equipment.
- 9 (2) Funds expended by the department for the purchase of AFIS 10 equipment for local consortiums shall be on a per capita basis.
- 11 (3) State funds shall not be used in the operation or maintenance 12 of AFIS equipment for local consortiums.
- Sec. 407. From the \$5,104,800.00 appropriated in section 101 for 14 AFIS, an amount of not more than \$260,000.00 is appropriated for local 15 AFIS equipment and shall be used for the state share of local AFIS 16 equipment. The total state share for this purpose shall not exceed 17 \$1,660,000.00 over the 4-year lease-purchase period. The per capita rate 18 to be established by the AFIS policy council shall not exceed a 4-year 19 total of \$41,000.00 per 100,000 population. State funds shall be limited 20 to the purchase of AFIS terminals that are on a 4-year lease-purchase 21 basis. LAW ENFORCEMENT OFFICERS TRAINING COUNCIL
- Sec. 501. The funds appropriated to the law enforcement officers 23 training council for training to locals is provided in accordance with 24 a state reimbursement policy in which 50% of the determined state 25 reimbursement rate shall be distributed on the first day of enrollment 26 and 50% upon certification by the law enforcement officers training 27 council.

28 EMERGENCY MANAGEMENT

- The state director of emergency management may expend Sec. 601. 2 funds appropriated under this act to call upon any agency or department 3 of the state or any recourse of the state to protect life or property or 4 to provide for the health or safety of the population in any area of the 5 state in which the governor proclaims a state of emergency under Act No. 6 302 of the Public Acts of 1945, being sections 10.31 to 10.33 of the 7 Michigan Compiled Laws, or under the emergency preparedness act, Act No. 8 390 of the Public Acts of 1976, being sections 30.401 to 30.420 of the 9 Michigan Compiled Laws. The state director of emergency management may 10 expend the amounts the director considers necessary to accomplish these 11 purposes. The director shall submit to the state budget director as soon 12 as possible a complete report of all actions taken under the authority 13 of this section. The report shall contain as a separate item a statement 14 of all funds expended that are not reimbursable from federal funds. 15 state budget director shall review the expenditures and submit 16 recommendations to the legislature in regard to any possible need for a 17 supplemental appropriation.
- 18 (2) In addition to the funds appropriated in section 101, the 19 department may receive and expend funds from local or private sources for 20 the purpose of providing emergency management training to local or 21 private interests.
- 22 (3) In addition to the funds appropriated in section 101, the 23 department may receive or expend funds from local, private, or state 24 sources for the purpose of supporting emergency preparedness response and 25 mitigation activity.

26 UNIFORM SERVICES

Sec. 701. Upon service of proper notification by the department 28 of intent to cancel the lease at any post that is subject to

- 1 consolidation, funds appropriated in section 101 shall not be used for 2 rent expenses at that post beyond the minimum time required for 3 cancellation of the lease.
- Sec. 702. The department shall not expend any portion of the funds appropriated in section 101 to plan for or to implement a roadblock or 6 check lane system that has as its primary objective the deterrence or 7 detection of intoxicated drivers in this state.

8 SPECIAL OPERATIONS

- 9 Sec. 801. Any county receiving state funds for consolidated 10 central dispatch under the provisions of this act shall:
- 11 (a) Provide full dispatch services to the department of state 12 police.
- 13 (b) Develop operational policy based on the concept of the 14 dispatch of the closest unit, of the appropriate type, to the service 15 request.
- Sec. 802. (1) Funds appropriated in section 101 for 9-1-1 17 consolidated central dispatch shall be for consolidated central dispatch 18 centers functioning on October 1, 1992 that meet the definition criteria 19 of a consolidated central dispatch as established by the department in 20 accordance with the June 2, 1988 central dispatch state plan 21 recommendations of the office of criminal justice emergency telephone 22 services committee.
- 23 (2) The funding formula for eligible consolidated central 24 dispatches shall use a rate not to exceed the state radio dispatcher FTE 25 pay rate exclusively for, and limited to, dispatchers, dispatch 26 supervisors, and center director personnel.
- 27 Sec. 803. (1) The funds appropriated in section 101 for the state 28 police radio/state government network system shall be considered a work

1 project account that shall not lapse at the end of the fiscal year.

2 (2) Funds appropriated under subsection (1) shall not be expended 3 without joint development of the system with the department of management 4 and budget.
