

# HOUSE BILL No. 5517

## EXECUTIVE BUDGET BILL

February 18, 1992, Introduced by Reps. Ostling, Knight, Sparks and Bender and referred to the Committee on Appropriations.

A bill to make appropriations for the state transportation department and certain transportation purposes for the fiscal year ending September 30, 1993; to provide for the imposition of fees; to provide for reports; to prescribe certain powers and duties of certain state departments and officials; and to provide for the expenditure of the appropriations.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1       Sec. 101. There is appropriated for the state transportation  
2 department and certain state purposes designated in this act for the

1 (2) When it appears to the principal executive officer of each  
2 department that state spending to local units of government will be less  
3 than the amount that was projected to be expended for any quarter, the  
4 principal executive officer shall immediately give notice of the  
5 approximate shortfall to the department of management and budget, the  
6 senate and house appropriations committees, and the senate and house  
7 fiscal agencies.

8 Sec. 202. The appropriations made and the expenditures authorized  
9 under this act and the departments, agencies, commissions, boards,  
10 offices, and programs for which an appropriation is made under this act  
11 are subject to the management and budget act, Act No. 431 of the Public  
12 Acts of 1984, being sections 18.1101 to 18.1594 of the Michigan Compiled  
13 Laws.

14 Sec. 203. As used in this act:

15 (a) "AASHTO" means the American association of state highway and  
16 transportation officials.

17 (b) "DOT" means the United States department of transportation.

18 (c) "DOTFHWA" means DOT federal highway administration.

19 (d) "DOTFRA" means DOT federal railroad administration.

20 (e) "DOTNHTSA" means DOT national highway traffic safety  
21 administration.

22 (f) "FTE" means fulltime equated.

23 (g) "IDG" means interdepartmental grant.

24 (h) "IDT" means intradepartmental transfer.

25 (i) "MBEWBE" means minority business enterprises and women's  
26 business enterprises.

27 (j) "SMART" means the suburban mobility authority for regional

1 transportation.

2 (k) "UMTA" means the urban mass transportation act of 1964.

3 (l) "FTACT" means the federal transit act.

4 Sec. 204. (1) Beginning October 1, 1992, there shall be a hiring  
5 freeze imposed on the state classified civil service. State departments  
6 and agencies shall be prohibited from hiring any new full-time state  
7 classified civil service employees or prohibited from filling any vacant  
8 state classified civil service positions. This hiring freeze does not  
9 apply to internal transfers of classified employees from one position to  
10 another within a department.

11 (2) The director of the department of management and budget shall  
12 grant exceptions to this hiring freeze when the director believes that  
13 such a hiring freeze will result in rendering a state department or  
14 agency unable to deliver basic services, cause loss of revenue to the  
15 State, result in the inability of the State to receive and expend federal  
16 funds, or necessitate additional expenditures that exceed any savings  
17 from maintaining a vacancy.

#### 18 DEPARTMENTAL SECTIONS

19 Sec. 301. The department may establish a fee schedule and collect  
20 fees sufficient to cover the costs of the issuance of the permits which  
21 the department is authorized by law to issue upon request, and for which  
22 fees are not otherwise stipulated by law.

23 Sec. 302. The department shall prepare an official transportation  
24 map which shall be distributed without charge. Each legislator shall  
25 receive a quantity of maps as determined by the legislative council.

27 Sec. 401. (1) The projected apportionment for this state for the  
28 fiscal year ending September 30, 1993, is \$527,900,000.00. The

15 (2) When the department receives authorization from the federal  
16 highway administration it may receive and expend those funds.

17 Sec. 402. If federal funding is reduced or eliminated for any rail  
18 passenger line within the state which includes the 4 lines operating from  
19 Grand Rapids Chicago, Port Huron Chicago, Detroit Chicago, and Detroit  
20 Toledo, then the balance in the accounts appropriated under rail  
21 passenger operating assistance for the lines operating from Grand Rapids  
22 Chicago and Port Huron Chicago may be used to continue the operations of  
23 any of the 4 rail passenger lines.

#### 24 MICHIGAN TRANSPORTATION FUND

25 Sec. 501. The state treasurer shall perform audits and make inves  
26 tigations of the disposition of all state funds received by county road  
27 commissions and cities and villages for transportation purposes to deter  
28 mine compliance with the terms and conditions of Act No. 51 of the Public

1 Acts of 1951, being sections 247.651 to 247.675 of the Michigan Compiled  
2 Laws. The county road commissions shall make available to the state  
3 treasurer the pertinent records for the audit.

4 Sec. 502. The appropriations in section 101 for the economic devel  
5 opment programs shall not lapse at the end of the fiscal year but shall  
6 carry forward each fiscal year for the purposes for which appropriated  
7 in accordance with Act No. 231 of the Public Acts of 1987, being sections  
8 247.901 to 247.914 of the Michigan Compiled Laws, and Act No. 233 of the  
9 Public Acts of 1987, being sections 247.931 to 247.933 of the Michigan  
10 Compiled Laws.

11 Sec. 503. Interest earned in the economic development fund shall  
12 remain in the fund and shall be allocated to the respective programs by  
13 estimate and adjusted to actual interest earned at the end of each fiscal  
14 year.

15 Sec. 504. The department of transportation economic development  
16 fund may receive and expend federal, local, or private funds for projects  
17 that are consistent with the programmatic mission of the fund in addition  
18 to funds appropriated in section 101.

#### 19 TRUNKLINE FUND

20 Sec. 601. Pursuant to section 11 of Act No. 286 of the Public Acts  
21 of 1964, being section 247.811 of the Michigan Compiled Laws, the amount  
22 appropriated in section 101 for the state transportation commission may  
23 be expended for per diem payments at the rate of \$75.00 per day, not to  
24 exceed \$10,000.00 in the fiscal year for each member of the state  
25 transportation commission.

#### 26 COMPREHENSIVE TRANSPORTATION FUND

27 Sec. 701. Money which is returned to the state as repayment for a  
28 loan for intercity bus equipment is not money to be deposited in the com

1 prehensive transportation fund under section 10b of Act No. 51 of the  
 2 Public Acts of 1951, being section 247.660b of the Michigan Compiled  
 3 Laws, but is money that is deposited in an intercity bus equipment fund  
 4 for appropriation for the purchase and repair of intercity bus equipment.  
 5 Proceeds received by the state from the sale of intercity bus equipment  
 6 are deposited in an intercity bus equipment fund for appropriation for  
 7 the purchase and repair of intercity bus equipment. Security deposits  
 8 from the lease of state owned intercity bus equipment not returned to the  
 9 lessee of such equipment under terms of the lease agreement are  
 10 deposited in an intercity bus equipment fund for appropriation for the  
 11 repair of intercity bus equipment.

12       Sec. 702. Money which is received by the state as repayment for  
 13 loans made for rail or water freight capital projects, and as a result  
 14 of the sale of a property or equipment used or projected to be used for  
 15 rail or water freight projects shall be deposited in the fund created by  
 16 section 17 of the state transportation preservation act of 1976, Act No.  
 17 295 of the Public Acts of 1976, being section 474.67 of the Michigan  
 18 Compiled Laws.

#### 19 AERONAUTICS FUND

20       Sec. 801. Rates charged by the department and expended for use of  
 21 state aircraft shall be sufficient to cover the cost of maintenance,  
 22 operation, repair, and replacement of the aircraft.
