- 5 SEC. 11A. THERE IS APPROPRIATED FROM THE STATE SCHOOL AID
- 6 FUND ESTABLISHED BY SECTION 11 OF ARTICLE IX OF THE STATE CONSTI-
- 7 TUTION OF 1963, FOR THE FISCAL YEAR ENDING SEPTEMBER 30, 1993,
- 8 THE SUM NECESSARY TO FULFILL THE REQUIREMENTS OF THIS SECTION,
- 9 AND ANY DEFICIENCY IS APPROPRIATED FROM THE GENERAL FUND BY THE

- 1 LEGISLATURE. EACH DISTRICT OR INTERMEDIATE DISTRICT SHALL
- 2 RECEIVE A PAYMENT NOT LATER THAN OCTOBER 15, 1992, A PAYMENT NOT
- 3 LATER THAN NOVEMBER 15, 1992, AND A PAYMENT NOT LATER THAN
- 4 DECEMBER 15, 1992. EACH PAYMENT SHALL BE IN AN AMOUNT EQUAL TO
