- Sec. 15a. (1) A peace officer who has reasonable cause to 7 believe that a violation of section 81 or 81a of Act No. 328 of 8 the Public Acts of 1931, as amended, being sections 750.81 and 9 750.81a of the Michigan Compiled Laws, has taken place or is
