being sections 484.2101 to 484.2605 of the Michigan Compiled Laws, by adding section 309b.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Act No. 179 of the Public Acts of 1991, being
- 2 sections 484.2101 to 484.2605 of the Michigan Compiled Laws, is
- 3 amended by adding section 309b to read as follows:
- 4 SEC. 309B. (1) AS USED IN THIS SECTION:
- 5 (A) "EXPLICIT SEXUAL MATERIAL" MEANS EITHER A RECORDED OR
- 6 LIVE TELEPHONE COMMUNICATION THAT IS A REPRESENTATION OR DESCRIP-
- 7 TION OF A SEXUAL ACT.
- 8 (B) "TELEPHONE MESSAGE SERVICE" MEANS A BUSINESS THAT
- 9 PROVIDES BY TELEPHONE A COMMERCIAL, INFORMATIONAL, PUBLIC

- 1 SERVICE, OR OTHER MESSAGE TO A CALLER FOR A SPECIFIC CHARGE THAT
- 2 WILL BE BILLED TO THE CALLER BY THE CALLER'S BASIC LOCAL EXCHANGE

- 4 (2) PRIOR TO THE PRESENTATION OF A MESSAGE, A TELEPHONE MES-
- 5 SAGE SERVICE SHALL NOTIFY THE CALLER OF THE COST OF THE CALL AND
- 6 THAT THE CHARGE WILL BE ITEMIZED ON THE CALLER'S TELEPHONE BILL.
- 7 THE CALLER SHALL ALSO BE NOTIFIED IF THE MESSAGE CONTAINS

- 9 (3) TO COMPLETE A CALL TO A TELEPHONE MESSAGE SERVICE WHOSE
- 10 MESSAGE CONTAINS EXPLICIT SEXUAL MATERIAL, THE CALLER SHALL HAVE
- 11 FIRST OBTAINED IN WRITING AN ACCESS CODE NUMBER OR OTHER PERSONAL
- 12 IDENTIFICATION NUMBER, CONSISTING OF NOT LESS THAN 9 DIGITS, FROM
- 13 THE TELEPHONE MESSAGE SERVICE. THE ACCESS CODE NUMBER OR PER-
- 14 SONAL IDENTIFICATION NUMBER NEEDED TO COMPLETE CALLS CONTAINING
- 15 EXPLICIT SEXUAL MATERIAL SHALL NOT BE ISSUED TO A MINOR.
- 16 (4) THE TELEPHONE MESSAGE SERVICE SHALL NOT COMPLETE A CALL
- 17 BEFORE RECEIVING THE ACCESS CODE NUMBER OR PERSONAL IDENTIFICA-
- 18 TION NUMBER.
- 19 (5) LOCAL TELEPHONE COMPANIES SHALL LIST ALL COMPLETED TELE-
- 20 PHONE MESSAGE SERVICE CALLS ON THE CUSTOMER'S TELEPHONE BILL AND
- 21 SHALL DESIGNATE THE TYPE OR TITLE OF THE MESSAGE.
- 22 (6) THE TELEPHONE COMPANY SHALL PROVIDE UPON REQUEST, AT NO
- 23 COST TO THE CUSTOMER, THE NAME AND ADDRESS OF A TELEPHONE MESSAGE
- 24 SERVICE PROVIDER ITEMIZED ON THE CUSTOMER'S BILL.
- 25 (7) A TELEPHONE MESSAGE SERVICE THAT VIOLATES THIS SECTION
- 26 IS GUILTY OF A MISDEMEANOR, PUNISHABLE BY IMPRISONMENT FOR NOT
- 27 MORE THAN 1 YEAR, OR BY A FINE OF NOT MORE THAN \$1,000.00, OR

- 1 BOTH. EACH CALL COMPLETED IN VIOLATION OF THIS SECTION SHALL BE
- 2 TREATED AS A SEPARATE OFFENSE UNDER THIS SUBSECTION.
