

HOUSE BILL No. 5582

March 3, 1992, Introduced by Rep. Profit and referred to the Committee on Judiciary.

A bill to amend section 8511 of Act No. 236 of the Public Acts of 1961, entitled as amended
"Revised judicature act of 1961,"
as amended by Act No. 266 of the Public Acts of 1990, being section 600.8511 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Section 8511 of Act No. 236 of the Public Acts
2 of 1961, as amended by Act No. 266 of the Public Acts of 1990,
3 being section 600.8511 of the Michigan Compiled Laws, is amended
4 to read as follows:

5 Sec. 8511. A district court magistrate ~~shall have~~ HAS the
6 following jurisdiction and duties:

7 (a) To arraign and sentence upon pleas of guilty or nolo
8 contendere for violations of the following acts or parts of acts,
9 or a local ordinance substantially corresponding to these acts or

1 parts of acts, when authorized by the chief judge of the district
2 court and if the maximum permissible punishment does not exceed
3 90 days in jail or a fine, or both:

4 (i) Michigan vehicle code, Act No. 300 of the Public Acts of
5 1949, as amended, being sections 257.1 to 257.923 of the Michigan
6 Compiled Laws, except for violations of ~~sections~~ SECTION 625
7 ~~and 625b~~ of Act No. 300 of the Public Acts of 1949, being
8 ~~sections~~ SECTION 257.625 ~~and 257.625b~~ of the Michigan
9 Compiled Laws. However, the magistrate may have the jurisdiction
10 to arraign defendants and set bond with regard to violations of
11 ~~sections~~ SECTION 625 ~~and 625b~~ of Act No. 300 of the Public
12 Acts of 1949.

1 (b) To issue warrants for the arrest of a person upon the
2 written authorization of the prosecuting or municipal attorney,
3 except written authorization shall not be required for a vehicle
4 law or ordinance violation within the jurisdiction of the magis-
5 trate if a police officer issued a traffic citation pursuant to
6 section 728 of the Michigan vehicle code, Act No. 300 of the
7 Public Acts of 1949, as amended, being section 257.728 of the
8 Michigan Compiled Laws, and the defendant failed to appear.

9 (c) To fix bail and accept bond in all cases.

10 (d) To issue search warrants, when authorized to do so by a
11 district court judge.

12 (E) TO ISSUE BENCH WARRANTS FOR ARREST, WHEN AUTHORIZED TO
13 DO SO BY THE CHIEF JUDGE OF THE DISTRICT COURT.
