- 5 trate if a police officer issued a traffic citation pursuant to
- 6 section 728 of the Michigan vehicle code, Act No. 300 of the
- 7 Public Acts of 1949, as amended, being section 257.728 of the
- 8 Michigan Compiled Laws, and the defendant failed to appear.
- 9 (c) To fix bail and accept bond in all cases.
- (d) To issue search warrants, when authorized to do so by a
- 11 district court judge.
- 12 (E) TO ISSUE BENCH WARRANTS FOR ARREST, WHEN AUTHORIZED TO
- 13 DO SO BY THE CHIEF JUDGE OF THE DISTRICT COURT.
