

HOUSE BILL No. 5602

March 3, 1992, Introduced by Rep. Jacobetti and referred to the Committee on Appropriations.

A bill to make appropriations for the public school employees' retirement system for the fiscal year ending September 30, 1993; to provide for the expenditure of those appropriations; and to provide for the disposition of other income received by the retirement system.

6 normal cost actuarial method and risk assumptions adopted by the retire-
7 ment board and the department of management and budget, from the school
8 aid fund established by section 11 of article IX of the state constitu-
9 tion of 1963.
