THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Sections 4 and 19 of Act No. 295 of the Public
- 2 Acts of 1982, as amended by Act No. 296 of the Public Acts of

- 4 Laws, are amended to read as follows:
- 5 Sec. 4. (1) After July 1, 1983, each support order entered
- 6 or modified by the circuit court shall provide for an order of
- 7 income withholding.
- 8 (2) Each support order entered by the circuit court on or
- 9 before July 1, 1983 shall be considered to provide for an order

- 1 of income withholding by operation of law, and income withholding
- 2 shall be implemented under the same circumstances and enforced in
- 3 the same manner as in the case of orders of income withholding
- 4 provided for pursuant to subsection (1). The office of the
- 5 friend of the court shall send notice of the provisions of this
- 6 subsection by ordinary mail to each payer under a support order

- Sec. 19. (1) If the court awards to the payer sole custody
- 22 of a child for whom the payer has been previously ordered to pay
- 23 support and a previously accumulated arrearage under the support
- 24 order for that child does not exist, the court shall modify any
- 25 existing support order to exclude support ordered to be paid by
- 26 that payer for that particular child. If an existing support
- 27 order does not provide for support to any other child of whom the

- 21 (4) If a written agreement is entered into pursuant to

- 23 THE order of income withholding shall take effect when the
- 24 requirement of section 7 is met.
- 25 (b) If the recipient of support becomes a recipient of
- 26 public assistance, the written agreement shall be null and void.

- 1 (5) The court may suspend or terminate an order of income 2 withholding if the custodial parent moves out of the state 3 without court authorization.
- 4 (6) The office of the friend of the court shall promptly 5 refund money that has been improperly withheld.
