

# HOUSE BILL No. 5681

March 9, 1992, Introduced by Rep. Harrison and referred to the Committee on Appropriations.

A bill to make appropriations for the department of agriculture for the Great Lakes draft horse show for the fiscal year ending September 30, 1992; and to provide for the expenditure of the appropriations.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1       Sec. 101. There is appropriated for the department of agriculture  
2 to supplement former appropriations for the fiscal year ending  
3 September 30, 1992, from the following funds:

#### 10 GENERAL SECTIONS

11       Sec. 201. (1) In accordance with the provisions of section 30 of  
12 article IX of the state constitution of 1963, total state spending in  
13 this appropriation act is \$104,000.00 and state appropriations to be paid  
14 to local units of government in section 101 are \$0.

15       (2) When it appears to the principal executive officer of each  
16 department that state spending to local units of government will be less  
17 than the amount that was projected to be expended for any quarter, the  
18 principal executive officer shall immediately give notice of the appro-  
19 priate shortfall to the department of management and budget, the senate  
20 and house appropriations committees, and the senate and house fiscal  
21 agencies.

22       Sec. 202. The appropriations made and expenditures authorized under  
23 this act and the departments, agencies, commissions, boards, offices, and  
24 programs for which an appropriation is made under this act are subject to  
25 the management and budget act, Act No. 431 of the Public Acts of 1984,  
26 being sections 18.1101 to 18.1594 of the Michigan Compiled Laws.

1       Sec. 301. Of the \$104,000.00 appropriated in section 101 for the  
2 Great Lakes draft horse show, \$35,500.00 shall be made available for the  
3 Michigan dynamometers association, \$58,500.00 shall be made available for  
4 the Michigan draft horse breeders association, and \$10,000.00 shall be  
5 used for advertisement and promotion of an annual Great Lakes interna-  
6 tional draft horse show.
