- 5 SEC. 643. (1) IF THE GUARDIAN OF A MINOR WITH DEVELOPMENTAL
- 6 DISABILITIES DESIRES TO OBTAIN AUTHORITY TO EXECUTE A RELEASE OF
- 7 THE MINOR AS REQUIRED BY SECTION 28(4) OF CHAPTER X OF ACT
- 8 NO. 288 OF THE PUBLIC ACTS OF 1939, BEING SECTION 710.28 OF THE
- 9 MICHIGAN COMPILED LAWS, OR EXECUTE A CONSENT TO THE MINOR'S

- (4) UPON HEARING A PETITION FILED PURSUANT TO SUBSECTION 2 (1), THE COURT SHALL AUTHORIZE THE GUARDIAN TO EXECUTE A RELEASE 3 OF THE MINOR OR EXECUTE A CONSENT TO THE ADOPTION OF THE MINOR BY 4 THAT GUARDIAN OR BY ANOTHER PERSON IF THE COURT IS SATISFIED THAT 5 THE WELFARE OF THE MINOR WILL BE SERVED BY THE RELEASE OR THE 6 CONSENT, SUBJECT TO SECTION 31 OF CHAPTER X OF ACT NO. 288 OF THE 7 PUBLIC ACTS OF 1939, BEING SECTION 710.31 OF THE MICHIGAN 8 COMPILED LAWS. (5) UPON HEARING A PETITION FILED PURSUANT TO SUBSECTION 10 (2), THE COURT SHALL AUTHORIZE THE GUARDIAN OF A PARENT WITH 11 DEVELOPMENTAL DISABILITIES TO EXECUTE A RELEASE OF THE PARENT'S 12 CHILD OR EXECUTE A CONSENT TO THE ADOPTION OF THE PARENT'S CHILD 13 BY THAT GUARDIAN OR BY ANOTHER PERSON IF THE COURT IS SATISFIED 14 THAT THE WELFARE OF THE PARENT'S CHILD WILL BE SERVED BY THE 15 RELEASE OR CONSENT, SUBJECT TO SECTION 31 OF CHAPTER X OF ACT 16 NO. 288 OF THE PUBLIC ACTS OF 1939, BEING SECTION 710.31 OF THE 17 MICHIGAN COMPILED LAWS.
