## **HOUSE BILL No. 5819**

A bill to amend Act No. 472 of the Public Acts of 1978, entitled

"An act to regulate political activity; to regulate lobbyists, lobbyist agents, and lobbying activities; to require registration of lobbyists and lobbyist agents; to require the filing of reports; to prescribe the powers and duties of the department of state; to prescribe penalties; and to repeal certain acts and parts of acts,"

as amended, being sections 4.411 to 4.431 of the Michigan Compiled Laws, by adding section 21a.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Act No. 472 of the Public Acts of 1978, as

- 3 Laws, is amended by adding section 21a to read as follows:

- 3 (2) A LOBBYIST OR A LOBBYIST AGENT SHALL NOT HAND DELIVER OR
- 4 CAUSE TO BE HAND DELIVERED A CAMPAIGN CONTRIBUTION TO A STATE
- 5 REPRESENTATIVE OR STATE SENATOR IN ANY OF THE FOLLOWING
- 6 BUILDINGS:

- 8 (B) A BUILDING HOUSING LEGISLATIVE OFFICES.
- 9 (C) A BUILDING ON A DAY A LEGISLATIVE COMMITTEE HAS MET IN
