- 1 (B) SELLING the -surplus, salvage, or scrap MATERIAL at 2 auction.
- 3 (C) DONATING OR SELLING THE MATERIAL TO A SHELTER FOR HOME-
- 4 LESS PERSONS, FOOD KITCHEN, FOOD BANK, OR OTHER ENTITY WHOSE PRI-
- 5 MARY PURPOSE IS TO PROVIDE OVERNIGHT ACCOMMODATION, FOOD, OR
- 6 MEALS FOR INDIGENT INDIVIDUALS, IF A CONTRIBUTION TO THAT ENTITY
- 7 IS TAX DEDUCTIBLE FOR THE DONOR UNDER THE INTERNAL REVENUE CODE.
