## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Act No. 641 of the Public Acts of 1978, as

- 4 follows:
- 5 SEC. 30B. (1) NOT LATER THAN JANUARY 1, 1996, A SOLID WASTE
- 6 HAULER SHALL DO BOTH OF THE FOLLOWING:
- 7 (A) CHARGE HIS OR HER CUSTOMERS ON THE BASIS OF THE WEIGHT
- 8 OF THE SOLID WASTE DISPOSED OF OR THE VOLUME OF THE SOLID WASTE
- 9 DISPOSED OF AS DETERMINED BY THE SOLID WASTE HAULER.

- 1 (B) PROVIDE FREE OF CHARGE TO HIS OR HER CUSTOMERS EITHER

- (5) AS USED IN THIS SECTION, "CURBSIDE COLLECTION" MEANS THE 6
- 7 COLLECTION OF RECYCLABLE MATERIALS FROM THE PROPERTY OF A CUS-
- 8 TOMER OR THE EDGE OF A ROAD BORDERING THE PROPERTY. FOR MULTI-
- 9 FAMILY RESIDENTIAL PROPERTY, CURBSIDE COLLECTION MAY INCLUDE A
- 10 CENTRAL COLLECTION LOCATION ON THE PROPERTY OF THE MULTIFAMILY
- 11 RESIDENTIAL PROPERTY.
