- 6 MAKE APPLICATION TO THE SECRETARY OF STATE FOR A SPECIAL REGIS-
- 7 TRATION PLATE, WHICH SHALL DISPLAY AN APPROPRIATE VIGNETTE
- 8 PRECEDING THE REGISTRATION NUMBERS.

- 1 (2) APPLICATION FOR A SPECIAL REGISTRATION PLATE SHALL BE ON

- 8 (4) A HOLDER OF A PLATE WHO NO LONGER QUALIFIES UNDER
- 9 SUBSECTION (2) SHALL IMMEDIATELY SURRENDER THE PLATE TO THE SEC-
- 10 RETARY OF STATE AND OBTAIN A REGULAR REGISTRATION PLATE. THE USE
- 11 OF A SPECIAL REGISTRATION PLATE ON A VEHICLE OTHER THAN THE VEHI-
- 12 CLE FOR WHICH THE PLATE IS ISSUED, OR BY A PERSON WHO DOES NOT
- 13 QUALIFY UNDER THIS SECTION, IS A MISDEMEANOR.
- 14 (5) THE SPECIAL REGISTRATION PLATE ISSUED UNDER THIS SECTION
- 15 SHALL EXPIRE ON THE BIRTHDAY OF THE VEHICLE OWNER IN A YEAR IN
- 16 WHICH NEW PLATES ARE ISSUED BY THE SECRETARY OF STATE.
- 17 APPLICATION FOR RENEWAL OF THE SPECIAL REGISTRATION PLATE SHALL
- 18 BE ACCOMPANIED BY A \$5.00 SERVICE FEE. THE APPLICANT SHALL NOT
- 19 BE REQUIRED TO FURNISH THE PROOF PROVIDED IN SUBSECTION (2).
