A bill to create the Michigan job academy; and to prescribe its powers and duties.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. This act shall be known and may be cited as the
- 2 "Michigan job academy act".
- 3 Sec. 2. As used in this act:
- 4 (a) "Job academy" means the Michigan job academy created in
- 5 section 3.
- 6 (b) "Statewide cabinet on career/technical education" means
- 7 the statewide cabinet on career/technical education created in
- 8 section 1287a of the school code of 1976, Act No. 451 of the
- 9 Public Acts of 1976, being section 380.1287a of the Michigan
- 10 Compiled Laws.
- 11 Sec. 3. (1) The Michigan job academy is created in the
- 12 department of management and budget to foster the efficient and

- 1 effective delivery of job training and retraining programs to all
- 2 persons in this state and to help create jobs in areas of high
- 3 unemployment in this state.
- 4 (2) The job academy shall consist of the following 13
- 5 members:
- 6 (a) The director of labor or his or her designee.
- 7 (b) The director of commerce or his or her designee.
- 8 (c) The director of social services or his or her designee.
- 9 (d) The director of mental health or his or her designee.
- (e) The director of the department of natural resources or
- 11 his or her designee.
- (f) The superintendent of public instruction or his or her
- 13 designee.
- (g) The director of the governor's office for job training.
- (h) Three representatives of business, 1 chosen by the gov-
- 16 ernor, 1 chosen by the senate majority leader, and 1 chosen by
- 17 the speaker of the house of representatives.
- (i) Three representatives of labor, 1 chosen by the gover-
- 19 nor, 1 chosen by the senate majority leader, and 1 chosen by the
- 20 speaker of the house of representatives.
- 21 (3) The representatives of business and labor shall serve
- 22 for 3-year terms, but may be reappointed.
- 23 (4) A vacancy shall be filled in the same manner as the
- 24 original appointment.
- (5) A member of the job academy shall not be paid a salary
- 26 for serving on the job academy, but each member may receive
- 27 reimbursement for actual and necessary travel and other expenses

- 1 incurred in the performance of official duties in accordance with
- 2 standard travel regulations of the department of management and
- 3 budget.
- 4 Sec. 4. The job academy shall do all of the following:
- 5 (a) Develop, coordinate, implement, and provide oversight of
- 6 all state job training programs.
- 7 (b) Recommend to the governor, the legislature, and the
- 8 statewide cabinet on career/technical education ways in which
- 9 state and federal job training programs may be improved and
- 10 expanded upon to meet current and future job training and eco-
- 11 nomic expansion needs.
- (c) Make available to persons in this state and to public
- 13 and private job training entities information and analyses on
- 14 state and federal job training programs.
- (d) Recommend to public and private job training entities
- 16 all of the following:
- (i) Ways to ensure greater access to state and federal job
- 18 training programs for dislocated and undertrained workers.
- 19 (ii) Ways to provide workers with the skills, education, and
- 20 training they will need to meet the future demands of technologi-
- 21 cal advancement and small business expansion.
- 22 (iii) Ways to link employment and job training programs with
- 23 short- and long-term economic development goals.
- (e) Periodically issue benchmarks that set dates certain for
- 25 the completion of programmatic goals related to the training and
- 26 education of workers in this state and to the creation of
- 27 high-skilled, high-paying jobs.

- 1 (f) Establish pilot programs that test strategies
- 2 recommended by the statewide cabinet on career/technical educa-
- 3 tion and the governor's office for job training to create jobs in
- 4 areas of high unemployment in this state, help employees upgrade
- 5 their skills, and support businesses that seek to improve the
- 6 skills of their workers through advanced job training.
- 7 (g) Establish job performance standards based on the highest
- 8 job performance standards found in any industry in any country
- 9 and require the application of these standards by selected job
- 10 training and pilot programs.
- (h) Issue a report on a quarterly basis to the public and to
- 12 state and federal job training entities that identify new skills
- 13 that businesses will require of workers.
- (i) Based on the reports issued pursuant to subdivision (h),
- 15 implement and revise, as necessary, state job training programs
- 16 and recommend, as necessary, changes to federal job training
- 17 programs.
- 18 Sec. 5. This act shall not take effect unless House Bill
- 19 No. 4165 of the 86th Legislature is enacted into law.
