- 1 JUDGMENT DEBTOR. THE JUDGMENT CREDITOR OR JUDGMENT CREDITOR'S
- 2 ATTORNEY OF RECORD SHALL FILE THE SATISFACTION OF JUDGMENT WITH
- 3 THE CLERK OF THE COURT IN WHICH THE JUDGMENT WAS ENTERED BEFORE
