July 22, 1992, Introduced by Rep. Kosteva and referred to the Committee on Taxation.

A bill to amend the title of Act No. 164 of the Public Acts of 1877, entitled as amended

"An act to authorize cities, incorporated villages, and townships to establish and maintain, or contract for the use of, free public libraries and reading rooms,"

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 6 (A) THE LIBRARY BOARD ADOPTS A RESOLUTION SUBMITTING THE

- (C) A MAJORITY OF THE QUALIFIED ELECTORS OF THE CITY, VIL-
- 19 LAGE, OR TOWNSHIP IN WHICH THE LIBRARY HAS BEEN ESTABLISHED
- 20 VOTING ON THE QUESTION APPROVE THE ISSUING OF THE GENERAL OBLIGA-
- 21 TION LIMITED TAX BONDS OR NOTES.
- 22 (3) THE QUESTION OF ISSUING GENERAL OBLIGATION UNLIMITED TAX

- 5 SUBSECTION (1), BUT SHALL BE CONSIDERED TO BE AUTHORIZED IN ADDI-
- 6 TION TO THE 5% LIMITATION.
- 7 SEC. 20. (1) THE SECRETARY OF A LIBRARY BOARD SHALL SUBMIT
- 8 TO THE GOVERNING BODY OF THE CITY, VILLAGE, OR TOWNSHIP THAT HAS
- 9 ESTABLISHED THE LIBRARY BOARD A COPY OF THE RESOLUTION SUBMITTING
- 10 THE QUESTION OF ISSUING UNLIMITED TAX GENERAL OBLIGATION BONDS OR
- 11 NOTES TO THE ELECTORS PURSUANT TO SECTION 18.
- 12 (2) UPON RECEIPT OF THE RESOLUTION OF THE LIBRARY BOARD SUB-
- 13 MITTING THE QUESTION OF ISSUING UNLIMITED TAX GENERAL OBLIGATION
- 14 BONDS OR NOTES TO THE ELECTORS, THE CLERK OF THE CITY, VILLAGE,
- 15 OR TOWNSHIP THAT HAS ESTABLISHED THE LIBRARY SHALL CERTIFY THE
- 16 OUESTION TO THE COUNTY CLERK PURSUANT TO THE MICHIGAN ELECTION
- 17 LAW, ACT NO. 116 OF THE PUBLIC ACTS OF 1954, BEING SECTIONS 168.1
- 18 TO 168.992 OF THE MICHIGAN COMPILED LAWS.
- 19 (3) THE CLERK OF THE CITY, VILLAGE, OR TOWNSHIP THAT HAS
- 20 ESTABLISHED THE FREE PUBLIC LIBRARY SHALL CONDUCT THE ELECTION ON
- 21 BEHALF OF THE LIBRARY BOARD. THE LIBRARY BOARD SHALL REIMBURSE
- 22 THE CITY, VILLAGE, OR TOWNSHIP FOR THE ACTUAL COSTS INCURRED IN
- 23 CONDUCTING THE ELECTION BASED ON THE NUMBER OF HOURS OF WORK DONE
- 24 IN CONDUCTING THE ELECTION, THE RATES OF COMPENSATION OF THE
- 25 WORKERS, AND THE COST OF MATERIALS SUPPLIED IN THE ELECTION.
- 26 SEC. 21. IF A MAJORITY OF THE QUALIFIED ELECTORS OF THE
- 27 CITY, VILLAGE, OR TOWNSHIP IN WHICH A FREE PUBLIC LIBRARY HAS

- 1 BEEN ESTABLISHED VOTING ON THE QUESTION OF ISSUING UNLIMITED TAX
- 2 BONDS OR NOTES APPROVES THE ISSUANCE, THE LIBRARY BOARD, BY RESO-
- 3 LUTION, SHALL AUTHORIZE AND LEVY THE TAXES NECESSARY TO PAY THE
- 4 PRINCIPAL OF AND INTEREST ON THE BONDS OR NOTES. THE TAXES SHALL
- 5 BE LEVIED AND COLLECTED IN THE SAME MANNER AS GENERAL TAXES OF
- 6 THE CITY, VILLAGE, OR TOWNSHIP.
- 7 SEC. 22. (1) BONDS AND NOTES ISSUED PURSUANT TO THIS ACT
- 8 ARE THE DEBT OF THE LIBRARY BOARD AND NOT OF THE CITY, VILLAGE,
- 9 OR TOWNSHIP IN WHICH THE FREE PUBLIC LIBRARY HAS BEEN
- 10 ESTABLISHED.
- 11 (2) BONDS AND NOTES ISSUED PURSUANT TO THIS ACT ARE SUBJECT
- 12 TO THE MUNICIPAL FINANCE ACT, ACT NO. 202 OF THE PUBLIC ACTS OF
- 13 1943, BEING SECTIONS 131.1 TO 139.3 OF THE MICHIGAN COMPILED
- 14 LAWS.
