THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 2619 of Act No. 368 of the Public Acts

- 5 Sec. 2619. (1) The department shall establish a registry to
- 6 record cases of cancer and other specified tumorous and precan-

- 1 necessary and appropriate in order to conduct epidemiologic
- 2 surveys of cancer and cancer-related diseases in the state.
- 3 (2) Each diagnosed case of cancer and other specified tumor-
- 4 ous and precancerous diseases AND OTHER INFORMATION DESCRIBED IN
- 5 SUBSECTION (!) shall be reported to the department pursuant to
- 6 -subsection SUBSECTIONS (4) AND (5), or reported to a cancer
- 7 reporting registry if the cancer reporting registry meets stan-
- 8 dards established pursuant to subsection (4) to ensure the accu-
- 9 racy and completeness of the reported information. A person or
- 10 facility required to report a diagnosis pursuant to subsection

- 16 SIZE OF THE HOSPITAL IN WHICH THE SURGERY WAS PERFORMED.
- 17 (6) -(5) This section does not compel an individual to
- 18 submit to medical or department examination or supervision.
- 19 (7) The department may contract for the collection and
- 20 analysis of, and research related to, the epidemiologic data
- 21 required under this section.
- 22 (8) (7) Within 2 years after the effective date of this
- 23 section BY JULY 1, 1986, the department shall begin evaluating
- 24 the reports collected pursuant to subsection (2). The department
- 25 shall publish and make available to the public reports summariz-
- 26 ing the information collected. The first summary report shall be
- 27 published not later than -180 days after the end of the first 2

- 2 JULY 1, 1987. Subsequent annual summary reports shall be made on
