- I section 400.231 of the Michigan Compiled Laws, shall provide the 2 following information relative to the custodial parent or absent 3 parent:
- 4 (a) Full name and address.
- 5 (b) Social security number.
- 6 (c) Date of birth.
- 7 (d) Amount of wages earned by or other income due the custo-
- 8 dial parent or absent parent. As used in this subdivision and
- 9 subdivision (e), "income" means income as defined in section 2 of
- 10 the support and visitation enforcement act, Act No. 295 of the
