A bill to amend section 8 of Act No. 297 of the Public Acts of 1937, entitled as amended

"Soil conservation districts law,"

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 8 of Act No. 297 of the Public Acts of
- 2 1937, as amended by Act No. 380 of the Public Acts of 1988, being
- 3 section 282.8 of the Michigan Compiled Laws, is amended to read
- 4 as follows:
- 5 Sec. 8: (1) A soil conservation district organized under
- 6 the provisions of this act shall constitute CONSTITUTES a gov-
- 7 ernmental subdivision of this state, and a public body corporate
- 8 and politic, exercising public powers. -, and a A soil
- 9 conservation district, and the directors of a district, -shall-

- 1 have all of the following powers, in addition to powers granted
- 2 in other sections of this act:
- 3 (a) To conduct surveys, investigations, and research relat-
- 4 ing to the character of soil erosion and the preventive and con-
- 5 trol measures needed, to publish the results of the surveys,
- 6 investigations, or research, and to disseminate information con-
- 7 cerning these preventive and control measures. In order to avoid
- 8 duplication of research activities, a district shall not initiate
- 9 any research program except in cooperation with the government of
- 10 this state or any of its agencies or with the United States or
- 11 any of its agencies.
- (b) To conduct demonstrational projects within the district
- 13 on -lands LAND owned or controlled by this state or any of its
- 14 agencies, with the cooperation of the agency administering and
- 15 having jurisdiction of the -lands LAND, and on any other -lands-
- 16 LAND within the district upon obtaining the consent of the owner
- 17 of the -lands LAND or the necessary rights or interest in the
- 18 -lands LAND, in order to demonstrate by example the means,
- 19 methods, and measures by which soil and soil resources may be
- 20 conserved and soil erosion in the form of soil blowing and soil
- 21 washing may be prevented and controlled.
- (c) To carry out preventive and control measures within the
- 23 district including, but not limited to, engineering operations,
- 24 methods of cultivation, the growing of vegetation, changes in use
- 25 of land, and other measures to achieve purposes listed in decla-
- 26 ration of policy, on -lands LAND owned or controlled by this
- 27 state or any of its agencies, with the cooperation of the agency

- 1 administering and having jurisdiction of the -lands- LAND, and on
- 2 any other -lands LAND within the district upon obtaining the
- 3 consent of the owner of the -lands- LAND or the necessary rights
- 4 or interests in the -lands LAND.
- 5 (d) To cooperate, or enter into agreements with, and within
- 6 the limits of appropriations made available to it by law, to fur-
- 7 nish financial or other aid to any agency, governmental or other-
- 8 wise, or any landowner, or his or her designated representative,
- 9 of -lands LAND within the district, in the carrying on of
- 10 erosion-control and prevention operations within the district,
- 11 subject to conditions as the directors -may consider necessary
- 12 to advance the purposes of this act.
- (e) To obtain options upon and to acquire, by purchase,
- 14 exchange, lease, gift, grant, bequest, devise, or otherwise, any
- 15 property, real or personal, or rights or interests in that prop-
- 16 erty; to maintain, administer, and improve any properties
- 17 acquired, to receive income from the properties and to expend
- 18 income in carrying out the purposes and provisions of this act;
- 19 and to sell, lease, or otherwise dispose of any of its property
- 20 or interests in property in furtherance of the purposes and the
- 21 provisions of this act.
- 22 (f) To make available, on the terms it prescribes, to land-
- 23 owners or their designated representatives within the district OR
- 24 TO OTHER SOIL CONSERVATION DISTRICTS, agricultural and engineer-
- 25 ing machinery and equipment, fertilizer, seeds, and seedlings,
- 26 and other material or equipment, as will assist the landowners or
- 27 their designated representatives to carry on operations upon

- 1 their lands LAND for the conservation of soil resources and for 2 the prevention and control of soil erosion.
- 3 (g) To construct, improve, and maintain structures as may be
- 4 necessary or convenient for the performance of any of the opera-
- 5 tions authorized in this act.
- 6 (h) To develop comprehensive plans for the conservation of
- 7 soil resources and for the control and prevention of soil erosion
- 8 within the district. The plans shall specify in such detail as
- 9 may be possible, the acts, procedures, performances, and avoid-
- 10 ances which THAT are necessary or desirable for the effectua-
- 11 tion of the plans, including the specification of engineering
- 12 operations, methods of cultivation, the growing of vegetation,
- 13 cropping programs, tillage practices, and changes in use of land;
- 14 and to publish the plans and information and bring them to the
- 15 attention of occupiers of -lands- LAND within the district.
- 16 (i) To take over, by purchase, lease, or otherwise, and to
- 17 administer any soil-conservation, erosion-control, or
- 18 erosion-prevention project located within its boundaries under-
- 19 taken by the United States or any of its agencies or by this
- 20 state or any of its agencies; to manage, as agent of the United
- 21 States or any of its agencies or of this state or any of its
- 22 agencies, any soil-conservation, erosion-control, or
- 23 erosion-prevention project within its boundaries; to act as agent
- 24 for the United States or any of its agencies or for this state or
- 25 any of its agencies in connection with the acquisition, construc-
- 26 tion, operation, or administration of any soil-conservation,
- 27 erosion-control, or erosion-prevention project within its

- 1 boundaries; to accept donations, gifts, and contributions in
- 2 money, services, materials, or otherwise, from the United States
- 3 or any of its agencies or from this state or any of its agencies,
- 4 and to use or expend the money, services, materials, or other
- 5 contributions in carrying on its operations subject to the poli-
- 6 cies and procedures adopted by the -state- committee, and to
- 7 accept money, gifts, and donations from any other source not
- 8 specified in this subdivision.
- 9 (j) To sue and be sued in the name of the district; to have
- 10 a seal that is judicially noticed; to have perpetual succession
- 11 unless terminated as provided in this act; to make and execute
- 12 contracts and other instruments necessary or convenient to the
- 13 exercise of its powers; to make, and from time to time amend and
- 14 repeal, rules and regulations in a manner that is not inconsis-
- 15 tent with this act to carry into effect its purposes and powers.
- (k) As a condition to the extending of any benefit under
- 17 this act to, or the performance of work upon, any -lands LAND
- 18 not owned or controlled by this state or any of its agencies, the
- 19 directors may require contributions in money, services, materi-
- 20 als, or otherwise to any operation conferring the benefits, and
- 21 may require land occupiers to enter into and perform agreements
- 22 or covenants as to the permanent use of the -lands- LAND that
- 23 will tend to prevent or control erosion on -those-lands THE
- 24 LAND.
- 25 (1) To act as the enforcing agency for a county if desig-
- 26 nated pursuant to section 6 of the soil erosion and sedimentation

- 1 control act of 1972, Act No. 347 of the Public Acts of 1972,
- 2 being section 282.106 of the Michigan Compiled Laws.
- 3 (2) Unless the legislature specifically states otherwise,
- 4 provisions with respect to the acquisition, operation, or dispo-
- 5 sition of property by other public bodies -shall not be- ARE NOT
- 6 applicable to a district. organized under this act.
