

HOUSE BILL No. 6206

November 12, 1992, Introduced by Reps. Byrum, Brackenridge, Shugars, Hoekman and Middaugh and referred to the Committee on Towns and Counties.

A bill to amend section 1 of Act No. 247 of the Public Acts of 1963, entitled

"An act to define the term "newspaper" as used in the statutes of this state regarding publication of notices,"

being section 691.1051 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Section 1. Section 1 of Act No. 247 of the Public Acts of
2 1963, being section 691.1051 of the Michigan Compiled Laws, is
3 amended to read as follows:

4 Sec. 1. (1) ~~The term~~ AS USED IN THIS ACT, "newspaper" ~~as~~
5 ~~used in any statute of this state, except the revised judicature~~
6 ~~act of 1961 relative to the publication of a notice of any kind,~~
7 ~~shall be construed to refer only to~~ MEANS a newspaper published
8 in the English language for the dissemination of local or
9 transmitted news and intelligence of a general character or for

1 the dissemination of legal news ~~—, which—~~ THAT MEETS BOTH OF THE
2 FOLLOWING REQUIREMENTS:

3 (a) ~~—has—~~ HAS a bona fide list of paying subscribers or has
4 been published ~~—at not less than weekly intervals—~~ in the same
5 community without interruption for at least 2 years. ~~—, and—~~

6 (b) ~~—has—~~ HAS been published and of general circulation ~~—at~~
7 ~~not less than weekly intervals—~~ without interruption for at least
8 1 year in the county, township, city, village, or district where
9 the notice is required to be published. A newspaper shall not
10 lose eligibility for interruption of continuous publication
11 because of acts of God, labor disputes, or because of military
12 service of the publisher for a period ~~—of—~~ not to exceed 2 years
13 ~~—and provided—~~ IF publication is resumed within 6 months follow-
14 ing the termination of ~~—such—~~ THE military service. ~~—~~

15 ~~—(c) annually averages at least 25% news and editorial con-~~
16 ~~tent per issue. The term "news and editorial content" for the~~
17 ~~purpose of this section means any printed matter other than~~
18 ~~advertising.—~~

19 (2) If no newspaper ~~—so—~~ qualifies in the county where the
20 court is situated, the term "newspaper" shall include ~~—any—~~ A
21 newspaper in an adjoining county ~~—which by this act is qualified~~
22 ~~to publish notice of actions commenced therein—~~ THAT OTHERWISE
23 MEETS THE REQUIREMENT OF SUBSECTION (1).

24 (3) THIS ACT DOES NOT APPLY TO THE TERM "NEWSPAPER" AS USED
25 IN THE REVISED JUDICATURE ACT OF 1961, ACT NO. 236 OF THE PUBLIC
26 ACTS OF 1961, BEING SECTIONS 600.101 TO 600.9947 OF THE MICHIGAN
27 COMPILED LAWS.
