- 19 gram who only receives reimbursement for the costs of operating

- 21 (g) A person who operates a motor home for personal
- 22 pleasure.
- 23 (H) A PARENT OR PARENT'S DESIGNEE FOR THE PURPOSE OF TRANS-
- 24 PORTING PUPILS TO OR FROM SCHOOL AND SCHOOL RELATED EVENTS UNDER
- 25 CONTRACT WITH THE SCHOOL.
