- 13 (b) "ED" means enumeration district as that term is used by
- 14 the United States department of commerce, bureau of the census in
- 15 conducting the 1990 decennial census.
- (c) "Tract" means tract as that term is used by the United
- 17 States department of commerce, bureau of the census in conducting
- 18 the 1990 decennial census.
