- 7 BIRTH MAY OBTAIN FROM THE STATE REGISTRAR, OR FROM A LOCAL
- 8 REGISTRAR HAVING JURISDICTION, A COMMEMORATIVE CERTIFICATE OF

- 1 BIRTH ISSUED BY THE DEPARTMENT PURSUANT TO RULES PROMULGATED BY

- 25 NOT BE USED FOR COMMERCIAL SOLICITATION OR PRIVATE GAIN.
- 26 (6) AFTER DEDUCTING THE COSTS OF ADMINISTERING THIS ACT, THE
- 27 STATE REGISTRAR AND EACH LOCAL REGISTRAR SHALL TRANSMIT THE MONEY

- 1 COLLECTED UNDER THIS SECTION TO THE STATE TREASURER FOR DEPOSIT
- 2 INTO THE CHILDREN'S TRUST FUND CREATED BY ACT NO. 249 OF THE
- 3 PUBLIC ACTS OF 1982, BEING SECTIONS 21.171 TO 21.172 OF THE
- 4 MICHIGAN COMPILED LAWS. THE DEDUCTION FOR ADMINISTRATIVE
- 5 EXPENSES AUTHORIZED UNDER THIS SECTION SHALL NOT EXCEED 50% OF
- 6 MONEY COLLECTED BY THE STATE REGISTRAR OR LOCAL REGISTRAR FOR
- 7 SPECIAL CERTIFICATES OF BIRTH.
