

# SENATE BILL No. 225

March 20, 1991, Introduced by Senator HOLMES and referred  
to the Committee on Appropriations.

## EXECUTIVE BUDGET BILL

A bill to make appropriations for the department of state police, and certain other state purposes for the fiscal year ending September 30, 1992; to provide for the expenditure of those appropriations; to provide for the disposition of other income received by the various state agencies; to provide testing of certain persons; to provide for certain emergency powers; and to provide for the powers and duties of certain committees, certain state agencies, and certain employees.

5 (2) When it appears to the principal executive officer of each  
 6 department that state spending to local units of government will be  
 7 less than the amount that was projected to be expended for any quarter,  
 8 the principal executive officer shall immediately give notice of the  
 9 approximate shortfall to the department of management and budget,  
 10 the senate and house appropriations committees, and the senate and  
 11 house fiscal agencies.

12 Sec. 202. The appropriations made and the expenditures authorized  
 13 under this act and the departments, agencies, commissions, boards,  
 14 offices, and programs for which an appropriation is made under this  
 15 act are subject to the management and budget act, Act No. 431 of the  
 16 Public Acts of 1984, being sections 18.1101 to 18.1594 of the Michigan  
 17 Compiled Laws.

18 Sec. 203. (1) It is the intent of the legislature that the funds  
 19 appropriated in section 101 will permit the department to carry out  
 20 each program for the entire fiscal year, unless a shorter period is  
 21 provided in law.

22 (2) The department shall not make or authorize an expenditure  
 23 or incur an obligation that exceeds or results in spending that will  
 24 exceed the amount appropriated in section 101 or as otherwise provided  
 25 by law.

26 (3) In consultation with the department of management and budget,

1 the department shall, for each appropriation, develop a spending plan  
2 allotting the amount appropriated over the full 12 months of the 1991-  
3 1992 fiscal year.

4 (4) The department director shall advise the director of the  
5 department of management and budget if an appropriation in section  
6 101 or otherwise provided by law will not permit that department to  
7 carry out the program specified by line item mandated by the  
8 legislature for the entire fiscal year. The department director shall  
9 consider both the amount appropriated for each line item and the  
10 sufficiency of projected sources of financing when deciding whether  
11 the appropriation will last the entire fiscal year. If the director  
12 of the department of management and budget concurs with the projections  
13 of that department, the director shall advise the chairpersons of  
14 the senate and house appropriations committees, and the chairpersons  
15 of the appropriate appropriations subcommittees that an amount  
16 appropriated in section 101 or as otherwise provided by law will not  
17 permit that department to carry out the program mandated by the  
18 legislature for the entire fiscal year.

19 (5) If both the appropriations committees disagree with the  
20 conclusion of the director within 10 days, the house fiscal agency  
21 and senate fiscal agency shall immediately publish estimates of whether  
22 the amount appropriated, including all sources of financing assumed  
23 in the appropriation, will permit that department to carry out the  
24 program mandated by the legislature for the entire fiscal year.

25 (6) If the legislature does not act within 30 days after the  
26 notice from the director provided in subsection (4) to reduce the

1 mandated level of service, authorize the program to end before the  
2 fiscal year is completed, or increase the amount of the appropriation,  
3 that department shall reduce the rate of spending in order to carry  
4 out the legislature's intent that the program be carried out for the  
5 full fiscal year.

6 Sec. 204. As used in this act:

7 (a) "AFIS" means automated fingerprint identification system.

8 (b) "AIS/ICF/MR" means alternate intermediate services,  
9 intermediate care facilities, mentally retarded.

10 (c) "CARE" means combined accident reduction effort.

11 (d) "CCD" or "consolidated central dispatch" means an entity  
12 consisting of 75% or more of the law enforcement, fire fighting, and  
13 emergency service agencies, or those agencies encompassing 75% or  
14 more of the population of the service area, joined under a written  
15 agreement to operate under a single dispatching operation. The 75%  
16 requirements for a CCD may be waived in counties of over 250,000 where  
17 other configurations promise effective and efficient services. A  
18 CCD must also include all of the following:

19 (i) The participation of the county sheriff and the state  
20 police.

21 (ii) The control of central dispatching by a countywide or  
22 regional authority consisting of representatives of participating  
23 jurisdictions and agencies and the general public, that selects  
24 supervisory staff and oversees operations.

25 (iii) One or 2 dispatching points operated by the authority  
26 as is determined to be necessary given the size of the county.

(iv) Dispatch services 24 hours a day, 7 days a week, year-round to all participating jurisdictions and agencies.

(v) A written agreement including an annual budget by the participants that specifies the nature and amount of service and identifies sources of financing, including the provision of personnel, equipment, supplies, and funds from participants or dedicated sources.

(vi) An operational policy based on the concept of the dispatch of the closest unit, of the appropriate type, to the service request.

(vii) Operation using 9-1-1, or enhanced 9-1-1, under the emergency telephone service enabling act, Act No. 32 of the Public Acts of 1986, being sections 484.1101 to 484.1707 of the Michigan Compiled Laws, where feasible and cost-effective.

(e) "CCH" means computerized criminal history.

(f) "Department" means the department of state police.

(g) "DMB" means the Michigan department of management and budget.

(h) "DOD" means United States department of defense.

(i) "DOJ" means the United States department of justice.

(j) "DOJ-BJS" means the United States department of justice, bureau of justice statistics.

(k) "DOT" means the United States department of transportation.

(l) "DOT-NHTSA" means DOT-national highway traffic safety administration.

(m) "FTE" means full-time equated.

(n) "IDG" means interdepartmental grant.

(o) "IDT" means intradepartmental transfer.

(p) "IDT" means intradepartmental transfer.

1 (q) "LEIN" means law enforcement information network.

2 (r) "MDOT" means Michigan department of transportation.

3 (s) "MLEOTC" means the Michigan law enforcement officer training  
4 council.

5 (t) "OHSP" means office of highway safety planning.

6 (u) "Title XVIII" means title XVIII of the Social Security Act  
7 of 1935 as amended.

8 Sec. 205. The appropriations provided in section 101 for salaries  
9 and wages, longevity and insurance, retirement, and pension, and for  
10 project accounts are approved for expenditure for automated information  
11 processing which is relevant to the objectives of the given  
12 appropriation unit or project account. Such expenditure shall not  
13 be applied to the \$20,000.00 limitation provided in section 203(2)  
14 of the management and budget act, Act No. 431 of the Public Acts of  
15 1984, being section 18.1203 of the Michigan Compiled Laws.

16 Sec. 206. The amounts appropriated for utilities and that portion  
17 of contractual services, supplies, and materials used to pay for  
18 utility service to state facilities in section 101 may be expended  
19 in a manner consistent with the provisions of section 253 of the  
20 management and budget act, Act No. 431 of the Public Acts of 1984,  
21 being section 18.1253 of the Michigan Compiled Laws.

22 EXECUTIVE DIRECTION

23 Sec. 301. Funds appropriated in section 101 for rental of  
24 department aircraft shall be considered a work project account and  
25 shall not lapse at the end of the fiscal year.

26 DEPARTMENTWIDE APPROPRIATIONS

1       Sec. 401. (1) Pursuant to the provisions of civil service rules  
2       and regulations and applicable collective bargaining agreements,  
3       individuals seeking employment with the department shall submit to  
4       a controlled substance test. The test shall be administered by the  
5       department.

6       (2) Individuals seeking employment with the department who refuse  
7       to take a controlled substance test or who test positive for the  
8       illicit use of a controlled substance on such a test shall be denied  
9       employment by the department for a minimum of 1 year.

10      (3) Funds shall not be expended by the MLEOTC for training law  
11      enforcement officer candidates, nor shall a candidate be certified  
12      by the MLEOTC, unless he or she tests negative on a test designed  
13      to detect the illicit use of a controlled substance. The test shall  
14      be conducted prior to basic training or application for certification.  
15      A candidate who tests positive or refuses to submit to the testing  
16      shall not be eligible for MLEOTC certification for a minimum of 2  
17      years.

18      (4) From the funds available in section 101, sufficient money  
19      is provided to maintain the substance abuse data base as provided  
20      for in the MLEOTC substance abuse testing program.

21      (5) The fire fighters training council shall consider requiring  
22      all new fire fighter candidates to submit to controlled substance  
23      testing procedures developed by the fire fighters training council  
24      and administered at the local level. At the discretion of the fire  
25      fighters training council, candidates may be required to pay the cost  
26      of a controlled substance test required by the fire fighters training

1 council. Candidates who refuse to submit to a controlled substance  
2 test as may be required by the fire fighters training council, or  
3 who test positive for the illicit use of a controlled substance on  
4 such a test, shall not be eligible for certification as a fire fighter  
5 for a minimum of 2 years.

#### 6 HIGHWAY SAFETY PLANNING

7 Sec. 501. (1) The amounts appropriated in section 101 for highway  
8 safety planning programs shall be treated as work project accounts  
9 and shall not revert to the general fund of the state at the conclusion  
10 of the fiscal year ending September 30, 1992, but shall continue to  
11 be available for expenditure until the projects for which they were  
12 appropriated are completed or otherwise terminated. At the conclusion  
13 of the fiscal year ending September 30, 1992, the unencumbered balance  
14 for each completed or terminated project shall revert to the general  
15 fund and unearned federal funds received for the completed or  
16 terminated project shall be returned.

17 (2) A principal executive officer of a department having an  
18 appropriation for highway safety planning funds shall notify the state  
19 budget director as to the September 30, 1992, status of each project  
20 for which appropriations are made. This notification shall be made  
21 by the following November 1, 1992, and shall be in sufficient detail  
22 so that the state budget director can cause the unencumbered balance  
23 of the completed or terminated projects to be reverted to the general  
24 fund of the state.

#### 25 CRIMINAL JUSTICE DATA CENTER

26 Sec. 601. In addition to the appropriations contained in section

1 101, the department may receive funds from local units of government  
2 for the purpose of expanding or upgrading the law enforcement  
3 information network, if the funds do not require state money for  
4 matching purposes, or for continuing programs if the funds from local  
5 units of government become unavailable.

6 Sec. 602. The \$1,823,100.00 appropriated in section 101 for  
7 the new computer shall be used for the purchase, installation, and  
8 contract maintenance of the new mainframe computer which shall continue  
9 to be funded by LEIN user fees sufficient to pay 1/3 of the purchase,  
10 installation, and contract maintenance costs.

11 Sec. 603. (1) The state budget director is authorized to make  
12 administrative transfers of the unexpended general fund-general purpose  
13 amounts available from amounts appropriated in section 101 to a special  
14 work project account for office automation in the department.

15 (2) The department shall certify to the department of management  
16 and budget by November 8, 1992 projected unexpended account balances  
17 available for transfer under the authority of subsection (1).

18 Sec. 604. (1) The funds appropriated in section 101 for the  
19 automated fingerprint identification system shall be considered a  
20 work project account that shall not lapse at the end of the fiscal  
21 year.

22 (2) In addition to funds appropriated under section 101, the  
23 department may receive and expend funds from local units of government  
24 pursuant to section 7 of A.F.I.S. policy council act, Act No. 307  
25 of the Public Acts of 1988, being section 28.157 of the Michigan  
26 Compiled Laws, for the purpose of acquiring equipment for the automated



1 finger print identification system.

2 Sec. 605. (1) The appropriations in section 101 include funds  
3 for the purchase of AFIS equipment.

4 (2) Funds expended by the department for the purchase of AFIS  
5 equipment for local consortiums shall be on a per capita basis.

6 (3) State funds shall not be used in the operations or maintenance  
7 of AFIS equipment for local consortiums.

8 Sec. 606. From the \$3,006,800.00 appropriated in section 101  
9 for AFIS, an amount not to exceed \$260,000.00 may be used for the  
10 state share of local AFIS equipment. The total state share for this  
11 purpose shall not exceed \$1,660,000.00 over the 4-year lease-purchase  
12 period. The per capita rate to be established by the AFIS policy  
13 council shall not exceed a 4-year total of \$41,000.00 per 100,000  
14 population. State funds shall be limited to the purchase of AFIS  
15 terminals that are on a 4-year lease-purchase basis. The state share  
16 shall not exceed 75%.

17 FIRE MARSHAL

18 Sec. 701. The department may contract with municipalities and  
19 private industries for specialized training in hazardous materials  
20 fire fighting.

21 EMERGENCY SERVICES

22 Sec. 801. (1) The state director of emergency services may expend  
23 funds appropriated under this act to call upon all agencies or  
24 departments of the state and all resources of the state for the purpose  
25 of protecting life and property and providing for the health and safety  
26 of the population in any area of the state in which the governor

1 proclaims a state of emergency under Act No. 302 of the Public Acts  
2 of 1945, being sections 10.31 to 10.33 of the Michigan Compiled Laws,  
3 or under the emergency preparedness act, Act No. 390 of the Public  
4 Acts of 1976, being sections 30.401 to 30.420 of the Michigan Compiled  
5 Laws. The state director of emergency services may expend the amounts  
6 the director considers necessary to accomplish these purposes. The  
7 director shall submit to the state budget director as soon as possible  
8 a complete report of all actions taken under the authority of this  
9 section. The report shall contain as a separate item a statement  
10 of all funds expended that are not reimbursable from federal funds.  
11 The state budget director shall review the expenditures and submit  
12 recommendations to the legislature in regard to any possible need  
13 for a supplemental appropriation.

14 (2) In addition to the appropriations contained in section 101,  
15 the department may receive and expend funds from local or private  
16 sources for the purpose of providing emergency management training  
17 to local or private interests.

18 (3) In addition to appropriations contained in section 101, the  
19 department may receive or expend funds from local or private sources  
20 for the purpose of supporting emergency preparedness response and  
21 mitigation activity.

## 22 UNIFORM SERVICES

23 Sec. 901. (1) Funds appropriated in section 101 for 9-1-1  
24 consolidated central dispatch shall be for continuation funding of  
25 existing consolidated central dispatches and new consolidated central  
26 dispatches that meet the definition criteria of a consolidated central

1 dispatch established by the department and the June 2, 1988 central  
2 dispatch state plan recommendations of the office of criminal justice  
3 emergency telephone services committee. Funds for continuation funding  
4 of existing consolidated dispatches and new consolidated central  
5 dispatches shall be expended in accordance with the guidelines  
6 established by the department and the April 4, 1989 office of criminal  
7 justice ad hoc subcommittee recommendations. These funds shall be  
8 considered a work project account and shall not lapse at the end of  
9 the fiscal year. The funding formula for new consolidated central  
10 dispatches shall use a rate not to exceed the state radio dispatcher  
11 FTE pay rate exclusively for, and limited to, dispatchers, dispatch  
12 supervisors, and center director personnel.

13 (2) All counties receiving state funds for consolidated central  
14 dispatches shall receive funding according to the consolidated central  
15 dispatch formula described in subsection (1).

#### 16 INVESTIGATIVE SERVICES

17 Sec. 1001. The funds appropriated in section 101 for federal  
18 anti-drug initiatives shall be limited to operations that include  
19 significant financial and personnel participation from local units  
20 of government. State funds may be utilized to maximize federal fund  
21 matching for antidrug initiatives.
