- 9 THE GOVERNING BOARD. A LICENSE GRANTED UNDER THIS SECTION MAY BE

- 12 DENT CENTER, WHICH HAS MEETING ROOMS, BANQUET AREAS, SOCIAL
- 13 HALLS, OVERNIGHT ACCOMMODATIONS, AND RELATED FACILITIES FOR SPE-
- 14 CIAL ACTIVITIES SCHEDULED BY THE UNIVERSITY, WHICH IN THE JUDG-
- 15 MENT OF THE COMMISSION, IS REGULARLY USED FOR CONFERENCES AND THE
- 16 LODGING OF GUESTS, AND PROVIDES CLASSROOM, LABORATORY, AND WORK

- 21 COMPREHENSIVE PROGRAM INVOLVING SKILLS IN PRODUCT KNOWLEDGE AND
- 22 THE SERVING OF ALCOHOLIC LIOUOR WITH CARE AND SOCIAL RESPONSIBIL-
- 23 ITY IN A STRUCTURED AND CONTROLLED EDUCATIONAL ENVIRONMENT. ONLY
- 24 THE KELLOGG CENTER FOR CONTINUING EDUCATION AT MICHIGAN STATE
- 25 UNIVERSITY SHALL BE CONSIDERED AN EDUCATIONAL CONFERENCE CENTER
- 26 FOR PURPOSES OF THIS SECTION.
