## SENATE BILL No. 382

June 12, 1991, Introduced by Senators DI NELLO, N. SMITH and KELLY and referred to the Committee on Transportation and Tourism.

A bill to amend section 628 of Act No. 300 of the Public Acts of 1949, entitled as amended

"Michigan vehicle code,"

as amended by Act No. 368 of the Public Acts of 1988, being section 257.628 of the Michigan Compiled Laws.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 628 of Act No. 300 of the Public Acts of
- 2 1949, as amended by Act No. 368 of the Public Acts of 1988, being
- 3 section 257.628 of the Michigan Compiled Laws, is amended to read
- 4 as follows:
- 5 Sec. 628. (1) If the state transportation <del>commission</del>
- 6 DEPARTMENT or county road commission, with respect to highways
- 7 under its jurisdiction, and the director of the department of
- 8 state police jointly determine upon the basis of an engineering
- 9 and traffic investigation that the speed of vehicular traffic on

- 1 a state trunk line or county highway is greater or less than is
- 2 reasonable or safe under the conditions found to exist at an
- 3 intersection or other place or upon a part of the highway, the
- 4 officials acting jointly may determine and declare a reasonable
- 5 and safe maximum or minimum speed limit on that state trunk line,
- 6 county highway, or intersection which shall be effective at the
- 7 times determined when appropriate signs giving notice of the
- 8 speed limit are erected at the intersection or other place or
- 9 part of the highway. If a superintendent of a school district
- 10 determines that the speed of vehicular traffic on a state trunk
- 11 line or county highway, which is within 1,000 feet of a school in
- 12 the school district of which that person is the superintendent,
- 13 is greater or less than is reasonable or safe, the officials
- 14 shall include the superintendent of the school district affected
- 15 in acting jointly in determining and declaring a reasonable and
- 16 safe maximum or minimum speed limit on that state trunk line or
- 17 county highway. THE MAXIMUM SPEED LIMIT ON ALL UNPAVED ROADS OR
- 18 PART OF AN UNPAVED ROAD WHICH CONSISTS OF CRUSHED STONE, SHALE,
- 19 SLAG, SAND, GRAVEL, OR OTHER AGGREGATE SHALL BE 40 MILES PER
- 20 HOUR. The maximum speed limit on all highways or parts of high-
- 21 ways upon which a maximum speed limit is not otherwise fixed pur-
- 22 suant to this act shall be 55 miles per hour. However, on all
- 23 highways or parts of highways upon which a maximum speed limit of
- 24 65 miles per hour is permitted by federal law, the maximum speed
- 25 limit shall be 65 miles per hour.
- 26 (2) If upon investigation the state transportation
- 27 -commission DEPARTMENT or county road commission and the

- 1 director of the department of state police find it in the
- 2 interest of public safety, they may order the township board, or
- 3 city or village officials to erect and maintain, take down, or
- 4 regulate the speed control signs, signals, or devices as
- 5 directed, and in default of an order the state transportation
- 6 -commission DEPARTMENT or county road commission may cause the
- 7 designated signs, signals, and devices to be erected and main-
- 8 tained, taken down, regulated, or controlled, in the manner pre-
- 9 viously directed, and pay for the erecting and maintenance,
- 10 removal, regulation, or control of the sign, signal, or device
- 11 out of the highway fund designated.
- 12 (3) A public record of all speed control signs, signals, or
- 13 devices authorized under this section shall be filed in the
- 14 office of the county clerk of the county in which the highway is
- 15 located, and a certified copy shall be prima facie evidence in
- 16 all courts of the issuance of the authorization. The public
- 17 record with the county clerk shall not be required as prima facie
- 18 evidence of authorization in the case of signs erected or placed
- 19 temporarily for the control of speed or direction of traffic at
- 20 points where construction, repairs, or maintenance of highways is
- 21 in progress, or along a temporary alternate route established to
- 22 avoid the construction, repair, or maintenance of a highway, if
- 23 the signs are of uniform design approved by the state transporta-
- 24 tion -commission DEPARTMENT and the director of the department
- 25 of state police and clearly indicate a special control, when
- 26 proved in court that the temporary traffic-control sign was
- 27 placed by the state transportation -commission DEPARTMENT or on

- 1 the authority of the state transportation -commission DEPARTMENT
- 2 and the director of the department of state police or by the
- 3 county road commission or on the authority of the county road
- 4 commission, at a specified location.
- 5 (4) A person who fails to observe an authorized speed or
- 6 traffic control sign, signal, or device is responsible for a
- 7 civil infraction.
- 8 (5) The minimum speed limit on all freeways shall be 45
- 9 miles per hour except if reduced speed is necessary for safe
- 10 operation or in compliance with law or in compliance with a spe-
- 11 cial permit issued by an appropriate authority.
- 12 (6) The maximum rates of speed allowed pursuant to this sec-
- 13 tion are subject to the maximum rates established pursuant to
- 14 section 629b, section 627(5) to (7) for certain vehicles and
- 15 vehicle combinations, and section 629(4).
- 16 (7) A citation or civil infraction determination for exceed-
- 17 ing a lawful maximum speed limit of 55 miles per hour by driving
- 18 65 miles per hour or less shall not be considered by any person
- 19 in establishing automobile insurance eligibility or automobile
- 20 insurance rates.
