## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 204 of Act No. 431 of the Public Acts of
- 2 1984, as added by Act No. 504 of the Public Acts of 1988, being
- 3 section 18.1204 of the Michigan Compiled Laws, is amended to read
- 4 as follows:
- 5 Sec. 204. (1) The department shall develop and implement
- 6 standardized risk management policies, practices, and procedures
- 7 for all state agencies.

- 1 (2) The department shall review all risk management related
- 2 programs of state agencies, including, but not limited to,
- 3 worker's compensation, disability management, insurance, safety,
- 4 loss control, claims handling, exposure analysis, accident inves-
- 5 tigation, and risk management information systems.
- 6 (3) After review by affected state agencies, the department
- 7 may administer selected risk management related programs as
- 8 described in subsection (2).
- 9 (4) The department shall review and approve all proposals
- 10 for the acquisition of insurance or related services for state
- 11 agencies and utilize self-insurance options where cost
- 12 effective.
- 13 (5) THE DIRECTOR SHALL DETERMINE ANNUALLY THE AMOUNT OF
- 14 MONEY NECESSARY TO PAY ALL BENEFITS ACCRUING TO STATE EMPLOYEES
- 15 UNDER THE WORKER'S DISABILITY COMPENSATION ACT OF 1969, ACT
- 16 NO. 317 OF THE PUBLIC ACTS OF 1969, BEING SECTIONS 418.101 TO
- 17 418.941 OF THE MICHIGAN COMPILED LAWS, AND THE METHOD BY WHICH
- 18 SUCH PAYMENT SHALL BE MADE. THE DIRECTOR MAY DETERMINE AND USE
- 19 THE MOST COST EFFECTIVE MEANS OF ADMINISTERING THE PAYMENT OF
- 20 THESE BENEFITS, EITHER THROUGH THE STATE ACCIDENT FUND OR OUTSIDE
- 21 CONTRACT.
- 22 Section 2. Section 6 of Act No. 388 of the Public Acts of
- 23 1913, being section 550.706 of the Michigan Compiled Laws, is
- 24 repealed.
