## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Act No. 350 of the Public Acts of 1980, as

- 5 SEC. 418. (1) AS USED IN THIS SECTION, "CHILD HEALTH SUPER-
- 6 VISION SERVICES" MEANS THE PERIODIC REVIEW OF A CHILD'S PHYSICAL
- 7 AND EMOTIONAL STATUS BY A PHYSICIAN OR PURSUANT TO A PHYSICIAN'S
- 8 SUPERVISION. A REVIEW SHALL INCLUDE A HISTORY, COMPLETE PHYSICAL
- 9 EXAMINATION, DEVELOPMENTAL ASSESSMENT, ANTICIPATORY GUIDANCE,

- 1 APPROPRIATE IMMUNIZATIONS, AND LABORATORY TESTS IN KEEPING WITH
- 2 PREVAILING MEDICAL STANDARDS.
- 3 (2) EFFECTIVE JANUARY 1, 1993, A HEALTH CARE CORPORATION
- 4 GROUP OR NONGROUP CERTIFICATE THAT PROVIDES BENEFITS FOR A FAMILY
- 5 MEMBER OF THE SUBSCRIBER SHALL, AS TO THAT FAMILY MEMBER'S BENE-
- 6 FITS, ALSO PROVIDE THAT THE BENEFITS APPLICABLE FOR CHILDREN
- 7 INCLUDE BENEFITS FOR CHILD HEALTH SUPERVISION SERVICES FROM THE
- 8 MOMENT OF BIRTH THROUGH THE AGE OF 21. EACH SUCH CERTIFICATE
- 9 SHALL PROVIDE BENEFITS, AT A MINIMUM, FOR CHILD HEALTH SUPERVI-
- 10 SION SERVICES AT APPROXIMATELY THE FOLLOWING AGE INTERVALS:
- 11 BIRTH, 2 MONTHS, 4 MONTHS, 6 MONTHS, 9 MONTHS, 12 MONTHS,
- 12 15 MONTHS, 18 MONTHS, 2 YEARS, 3 YEARS, 4 YEARS, 5 YEARS,
- 13 6 YEARS, 8 YEARS, 10 YEARS, 12 YEARS, 14 YEARS, 16 YEARS,
- 14 18 YEARS, AND 20 YEARS. A CERTIFICATE MAY PROVIDE THAT CHILD
- 15 HEALTH SUPERVISION SERVICES THAT ARE RENDERED DURING A PERIODIC
- 16 REVIEW SHALL ONLY BE COVERED TO THE EXTENT THAT THOSE SERVICES
- 17 ARE PROVIDED BY OR UNDER THE SUPERVISION OF A SINGLE PHYSICIAN
- 18 DURING THE COURSE OF 1 VISIT.
- 19 (3) BENEFITS FOR CHILD HEALTH SUPERVISION SERVICES SHALL BE
- 20 EXEMPT FROM ANY COPAYMENT, COINSURANCE, DEDUCTIBLE, OR DOLLAR
- 21 LIMIT PROVISIONS IN THE CERTIFICATE, AND SUCH EXEMPTION SHALL BE
- 22 EXPLICITLY PROVIDED FOR IN THE CERTIFICATE.
