SENATE BILL No. 549

October 17, 1991, Introduced by Senators FAXON, STABENOW, HONIGMAN, HOLMES, POLLACK and GEAKE and referred to the Committee on Government Operations.

A bill to create an Asian Pacific American affairs commission and an office of Asian Pacific American affairs and to prescribe their powers and duties; and to prescribe the powers and duties of certain state agencies, departments, and officials.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. This act shall be known and may be cited as the
- 2 "Asian Pacific American affairs commission act".
- 3 Sec. 2. As used in this act:
- 4 (a) "Asian Pacific American" means a person who has origins
- 5 in any of the original peoples of the far east, southeast Asia,
- 6 the Indian subcontinent, or the Pacific islands; is identified by
- 7 an employer in an EEO-1 report as Asian or Pacific islander; or
- 8 is regarded in the community as having origins in any of the
- 9 original peoples of the far east, southeast Asia, the Indian
- 10 subcontinent, or the Pacific islands.

- 1 (b) "Commission" means the Asian Pacific American affairs
- 2 commission created in section 3.
- 3 (c) "Department" means the department of management and 4 budget.
- 5 (d) "Director" means the director of the office of Asian6 Pacific American affairs.
- 7 (e) "Office" means the office of Asian Pacific American 8 affairs created in section 11.
- 9 Sec. 3. (1) An Asian Pacific American affairs commission is
- 10 created in the department of management and budget. The commis-
- 11 sion shall exercise its powers and duties independently of the
- 12 department except for budget, procurement, and housekeeping
- 13 functions. The commission shall consist of 15 members appointed
- 14 by the governor with the advice and consent of the senate. The
- 15 commission annually shall elect a chairperson and
- 16 vice-chairperson, and shall elect other officers from its members
- 17 as it considers advisable.
- 18 (2) Members of the commission shall be of Asian or Pacific
- 19 islander origin or descent. The membership of the commission
- 20 shall consist of both men and women and shall be appointed from
- 21 geographical areas representative of Asian Pacific Americans
- 22 throughout this state.
- 23 (3) Except for initial members, a member of the commission
- 24 shall serve for a term of 3 years or until a successor is
- 25 appointed. Of the members initially appointed, 5 of the members
- 26 shall be appointed for a term of 3 years, 5 of the members shall
- 27 be appointed for a term of 2 years, and 5 of the members shall be

- 1 appointed for a term of 1 year. A vacancy on the commission
- 2 shall be filled by the governor for the balance of the unexpired
- 3 term.
- 4 (4) The commission shall be appointed within 90 days after
- 5 the effective date of this act.
- 6 Sec. 5. (1) Within 90 days after appointment and confirma-
- 7 tion of all members, the commission shall adopt bylaws for the
- 8 operation of the commission. The bylaws shall include, at a min-
- 9 imum, voting procedures and minimum requirements for attendance
- 10 at meetings.
- 11 (2) The commission shall hold regular quarterly meetings at
- 12 places and on dates fixed by the commission. Special meetings
- 13 may be called by the chairperson or by not less than 8 commission
- 14 members on 3 business days' actual notice.
- (3) A majority of the commission members appointed and serv-
- 16 ing constitutes a quorum. Final action by the commission shall
- 17 be only by affirmative vote of a majority of the commission mem-
- 18 bers appointed and serving. A commission member shall not vote
- 19 by proxy.
- 20 (4) The legislature annually shall fix the per diem compen-
- 21 sation of members of the commission. Expenses of members
- 22 incurred in the performance of official duties shall be reim-
- 23 bursed as provided by law for state employees.
- 24 (5) The department shall furnish administrative services to
- 25 the commission and shall provide secretarial and other staff nec-
- 26 essary to allow the proper exercise of the powers and duties of
- 27 the commission. The department shall provide adequate office

- 1 space to the commission. The department shall make available the
- 2 times and places of commission meetings and keep minutes of the
- 3 meetings and a record of the actions of the commission.
- 4 (6) The department shall assign professional employees to
- 5 staff the commission to assist the commission in the performance
- 6 of its substantive responsibilities under this act.
- 7 Sec. 7. (1) A meeting of the commission shall be held pur-
- 8 suant to the open meetings act, Act No. 267 of the Public Acts of
- 9 1976, being sections 15.261 to 15.275 of the Michigan Compiled
- 10 Laws. Public notice of the time, date, and place of the meeting
- 11 shall be given in the manner required by Act No. 267 of the
- 12 Public Acts of 1976.
- 13 (2) A writing prepared, owned, used, in the possession of,
- 14 or retained by the commission or office in the performance of an
- 15 official function shall be made available to the public pursuant
- 16 to the freedom of information act, Act No. 442 of the Public Acts
- 17 of 1976, being sections 15.231 to 15.246 of the Michigan Compiled
- 18 Laws.
- 19 Sec. 9. The commission shall do all of the following:
- 20 (a) Stimulate and encourage the study and review of the
- 21 status of Asian Pacific Americans in this state.
- 22 (b) Develop a unified policy and plan of action to serve the
- 23 needs of Asian Pacific Americans in this state.
- 24 (c) Advise the governor, the legislature, and the office
- 25 concerning the coordination and administration of state programs
- 26 serving Asian Pacific Americans.

- 1 (d) Make recommendations to the governor and legislature
- 2 regarding changes in state programs, statutes, and policies.
- 3 (e) Advise the governor and legislature of the nature, mag-
- 4 nitude, and priorities of the problems of Asian Pacific Americans
- 5 in this state.
- 6 (f) Review and advise the governor and the legislature on
- 7 the state's policies concerning Asian Pacific American affairs.
- 8 (g) Secure appropriate recognition of Asian Pacific American
- 9 accomplishments and contributions to this state.
- 10 (h) Review and approve the annual report by the office of
- 11 Asian Pacific American affairs as described in section 13(j).
- 12 (i) Make recommendations to the governor and legislature
- 13 regarding methods of overcoming discrimination against Asian
- 14 Pacific Americans in public and private employment and civil and
- 15 political rights.
- 16 (i) Work to ensure equal access to all levels of education
- 17 for Asian Pacific Americans.
- 18 (k) Promote methods to ensure equal access to state services
- 19 for Asian Pacific Americans.
- 20 (1) Cooperate with and coordinate activities with the Indian
- 21 affairs commission, the commission on Spanish-speaking affairs,
- 22 the Michigan women's commission, and any other commission which
- 23 deals with minority or ethnic affairs.
- 24 (m) Monitor, evaluate, investigate, advocate, and initiate
- 25 programs for the betterment of Asian Pacific Americans in this
- 26 state.

- 1 (n) Serve as a clearinghouse for incidents of anti-Asian and
- 2 anti-Pacific islander American harassment in this state.
- 3 (o) Promote public awareness of Asian and Pacific islander4 cultures.
- 5 Sec. 11. (1) The office of Asian Pacific American affairs
- 6 is created in the department of management and budget.
- 7 (2) The commission shall select the director of the office
- 8 with the concurrence of the director of the department of manage-
- 9 ment and budget in accordance with state civil service
- 10 procedures.
- 11 (3) The department shall furnish administrative services to
- 12 the office and shall provide secretarial and other staff neces-
- 13 sary to allow the proper exercise of the powers and duties of the
- 14 office. The department shall provide adequate office space to
- 15 the office.
- 16 (4) The department shall assign professional employees to
- 17 staff the office necessary to assist the office in the per-
- 18 formance of its substantive responsibilities under this act.
- 19 Sec. 13. The office shall do all of the following:
- 20 (a) Provide the commission with information concerning the
- 21 problems of Asian Pacific Americans and implement commission
- 22 policy.
- 23 (b) Conduct studies and recommend solutions to the problems
- 24 of Asian Pacific Americans in the areas of education, employment,
- 25 civil rights, health, housing, senior citizens, mental health,
- 26 social services, commerce, and other related areas.

- (c) Recommend to federal, state, and local governmental
 departments and agencies the creation of services and facilities
 as needed.
- 4 (d) Serve as a clearinghouse for the collection and distri-5 bution of information on Asian Pacific American affairs.
- 6 (e) Apply for and accept grants and gifts from governmental7 and private sources.
- 8 (f) Request the services of all state and local governmental
 9 departments and agencies to assure that Asian Pacific Americans
 10 have access to decision making bodies, the policies of which
 11 affect Asian Pacific Americans in this state.
- 12 (g) Cooperate with departments and agencies to aid in effec-13 tuating the purposes of this act.
- (h) Review the performance of state departments and agencies regarding the hiring and promotion of Asian Pacific Americans by the state departments and agencies and the provision of services to Asian Pacific Americans by the state departments and agencies.
- (i) Review the curriculum programs and policies of elementa20 ry, secondary, and postsecondary educational institutions of this
 21 state regarding Asian Pacific Americans and the admissions pro22 grams and policies of postsecondary educational institutions of
 23 this state regarding Asian Pacific Americans.
- (j) Submit a full written report of its activities and reczonmendations each year to the governor, legislature, and various Asian Pacific American communities throughout the state.
