- 1 county, municipal, or other local tax, and shall not be subject
- 2 to execution, garnishment, attachment, the operation of bank-
- 3 ruptcy or insolvency laws, or other process of law, and shall be
- 4 unassignable except as otherwise provided in this act.
- 5 (2) The right of a member, member on deferred retirement
- 6 status under section 20(4), or retirant to a pension, an annuity,
- 7 a retirement allowance, any optional benefit, accumulated contri-
- 8 butions, or any other benefit under the provisions of this act
- 9 shall be subject to award by a court pursuant to section 18 of
- 10 chapter 84 of the Revised Statutes of 1846, being section 552.18
- 11 of the Michigan Compiled Laws, and to any other order of a court
- 12 pertaining to alimony or child support. The right of a member,
