THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 53 of Act No. 427 of the Public Acts of

- 3 section 38.1553 of the Michigan Compiled Laws, is amended to read
- 4 as follows:
- 5 Sec. 53. (1) The right of an individual to a retirement
- 6 allowance, to the return of accumulated contributions, the
- 7 retirement allowance itself, any other right accrued or accruing
- 8 to an individual under this act, and any money belonging to the
- 9 retirement system is not subject to execution, garnishment,

- 1 attachment, the operation of bankruptcy or insolvency law, or any
- 2 other process of law whatsoever, and is unassignable, except as
- 3 is otherwise specifically provided in this act. A PENSION, A
- 4 RETIREMENT ALLOWANCE, THE RETURN OF ACCUMULATED CONTRIBUTIONS, AN
- 5 OPTIONAL BENEFIT, OR ANY OTHER BENEFIT OR RIGHT ACCRUED OR ACCRU-
- 6 ING TO A PERSON UNDER THIS ACT IS SUBJECT TO TAXATION UNDER THE
- 7 INCOME TAX ACT OF 1967, ACT NO. 281 OF THE PUBLIC ACTS OF 1967,

- 9 (2) The right of an individual to a retirement allowance, to
- 10 the return of accumulated contributions, the retirement allowance
- 11 itself, or any other benefit under this act is subject to award
- 12 by a court pursuant to section 18 of chapter 84 of the Revised
- 13 Statutes of 1846, being section 552.18 of the Michigan Compiled
- 14 Laws, and to any other order of a court pertaining to alimony or
- 15 child support. The right of an individual to a retirement allow-
- 16 ance, to the return of accumulated contributions, the retirement

- 18 to an eligible domestic relations order under the eligible domes-

- 11 contained in this subsection does not apply to the accumulated

- 13 acquiring a vested member status.
- 14 (4) The retirement system shall have the right of setoff to
- 15 recover overpayments made by the retirement system and to satisfy
- 16 any claim arising from embezzlement or fraud by a member, retir-
- 17 ant, or beneficiary. A transfer of money and assets to another
- 18 retirement system authorized by an affirmative vote by a majority
- 19 of the members on the municipality's governing body is not a vio-
- 20 lation of this section.
- 21 Section 2. This amendatory act shall not take effect unless
- 22 Senate Bill No. 131 of the 86th Legislature is enacted into law.
