- Section 1. Sections 3 and 4 of Act No. 107 of the Public

- Sec. 3. In addition to any other taxes imposed by law, there
- 5 is hereby imposed and there shall be levied and collected a spe-

- 7 ALL spirits, as THAT TERM IS defined in section 2 of THE MICHIGAN
- 8 LIQUOR CONTROL ACT, Act No. 8 of the Public Acts of the Extra
