"The district library establishment act," being section 397.182 of the Michigan Compiled Laws.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Section 12 of Act No. 24 of the Public Acts of
- 2 1989, being section 397.182 of the Michigan Compiled Laws, is
- 3 amended to read as follows:
- 4 Sec. 12. (1) A board may do 1 or more of the following:
- 5 (a) Establish, maintain, and operate a public library for
- 6 the district.
- 7 (b) Appoint and remove officers from among its members.
- 8 (c) Appoint and remove a librarian and necessary assistants
- 9 and fix their compensation.

- 1 (d) Acquire real or personal property for use for library
- 2 purposes by purchase, land contract, installment purchase
- 3 contract, lease with or without option to purchase, or title
- 4 retaining contract.
- 5 (e) Erect buildings.
- 6 (f) Supervise and control district library property.
- 7 (g) Enter into a contract to receive library-related service
- 8 from or give library-related service to a library or a municipal-
- 9 ity within or without the district.
- 10 (h) Adopt bylaws and regulations, not inconsistent with this
- 11 act, governing the board and the district library.
- 12 (i) Propose and levy upon approval of the electors as pro-
- 13 vided in this act a tax for support of the district library.
- 14 (j) Borrow money pursuant to the district library financing

- 19 (1) Accept gifts and grants for the district library.
- 20 (m) Do any other thing necessary for conducting the district
- 21 library service, the cost of which shall be charged against the
- 22 district library fund.
- 23 (2) A board may reimburse a board member for necessary
- 24 expenses that the member incurs in the performance of official
- 25 duties. A board may compensate board members for attending meet-
- 26 ings of the board and shall include the amount of compensation in
- 27 the annual budget. Compensation shall not exceed \$30.00 per

- 1 board member per meeting. A board member shall not be
- 2 compensated for attending more than 52 meetings per year.
- 3 (3) Money for the district library shall be paid to the
- 4 board and deposited in a fund known as the district library
- 5 fund. The board shall exclusively control the expenditure of
- 6 money deposited in the district library fund. THE BOARD MAY PRO-
- 7 VIDE FOR THE INVESTMENT OF MONEY IN THE DISTRICT LIBRARY FUND IN
- 8 THE SAME MANNER AS THE LEGISLATIVE BODY OF A CITY UNDER ACT
- 9 NO. 40 OF THE PUBLIC ACTS OF THE FIRST EXTRA SESSION OF 1932,
- 10 BEING SECTIONS 129.11 TO 129.15 OF THE MICHIGAN COMPILED LAWS, OR
- 11 ACT NO. 20 OF THE PUBLIC ACTS OF 1943, BEING SECTIONS 129.91 TO
- 12 129.94 OF THE MICHIGAN COMPILED LAWS.
