SENATE BILL No. 671

December 17, 1991, Introduced by Senators KELLY and V. SMITH and referred to the Committee on Family Law, Criminal Law, and Corrections.

A bill to amend section 4 of Act No. 389 of the Public Acts of 1978, entitled

"An act to provide for the prevention and treatment of domestic violence; to develop and establish policies, procedures, and standards for providing domestic violence assistance programs and services; to create a domestic violence prevention and treatment board and prescribe its powers and duties; to establish a domestic violence prevention and treatment fund and provide for its use; and to prescribe powers and duties of the department of social services,"

being section 400.1504 of the Michigan Compiled Laws; and to add section 4a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 25 OUESTIONS TO BE ASKED AND INFORMATION NEEDED IN THOSE
- 26 SITUATIONS.

- 2 AGENCIES IN THIS STATE.
- 3 (C) PRESENTATION IN CLEARLY UNDERSTANDABLE LANGUAGE, IN
- 4 QUESTION FORM TO THE EXTENT FEASIBLE.
- 5 (D) USE OF CHECK BOXES, TO THE EXTENT FEASIBLE, TO PERMIT A
- 6 PEACE OFFICER TO CHECK OFF THE APPROPRIATE ANSWERS.
- 7 (E) PROVISION OF SUFFICIENT SPACE FOR NECESSARY WRITTEN
- 8 ANSWERS OR OBSERVATIONS.
- 9 (F) A DESIGN PERMITTING A PEACE OFFICER TO GIVE A COMPLETED
- 10 COPY TO THE VICTIM BEFORE LEAVING THE SCENE.
- 11 (3) THE DOMESTIC VIOLENCE REPORTING FORM SHALL IDENTIFY THE
- 12 NAME AND PHONE NUMBER OF THE RESPONDING LAW ENFORCEMENT AGENCY.
- 13 (4) THE DOMESTIC VIOLENCE REPORTING FORM SHALL HAVE APPRO-
- 14 PRIATE CAPTIONS, QUESTIONS, AND SPACE TO RECORD ALL OF THE
- 15 FOLLOWING:
- 16 (A) THE ADDRESS, DATE, AND TIME OF THE OCCURRENCE OR INCI-
- 17 DENT BEING INVESTIGATED.
- 18 (B) THE VICTIM'S NAME, ADDRESS, HOME AND WORK PHONE NUMBERS,
- 19 RACE, SEX, AND DATE OF BIRTH.
- 20 (C) THE SUSPECT'S NAME, ADDRESS, HOME AND WORK PHONE NUM-
- 21 BERS, RACE, SEX, DATE OF BIRTH; INFORMATION DESCRIBING THE SUS-
- 22 PECT; AND WHETHER A RESTRAINING ORDER COVERING THE SUSPECT
- 23 EXISTS.
- 24 (D) THE NAME, ADDRESS, HOME AND WORK TELEPHONE NUMBERS,
- 25 RACE, SEX, AND DATE OF BIRTH OF ANY WITNESS AND THE RELATIONSHIP
- 26 OF THE WITNESS TO THE SUSPECT OR VICTIM.

- 1 (E) THE FOLLOWING INFORMATION ABOUT THE OCCURRENCE OR
- 2 INCIDENT BEING INVESTIGATED:
- 3 (i) WHO CALLED THE LAW ENFORCEMENT AGENCY.
- 4 (ii) THE RELATIONSHIP OF THE VICTIM AND SUSPECT.
- 5 (iii) THE NAME, AGE, SEX, ADDRESS, AND PHONE NUMBER OF ANY
- 6 WITNESS.
- 7 (iv) WHETHER ANY CHILD OF THE VICTIM WAS PRESENT, INCLUDING
- 8 THE CHILD'S AGE AND SEX.
- 9 (v) WHETHER ALCOHOL OR CONTROLLED SUBSTANCE USE WAS INVOLVED
- 10 IN THE OCCURRENCE OR INCIDENT, AND BY WHOM.
- 11 (vi) A BRIEF EXPLANATION OF WHAT LED TO THE OCCURRENCE OR
- 12 INCIDENT.
- 13 (vii) WHETHER AND HOW MANY TIMES THE SUSPECT PHYSICALLY
- 14 ASSAULTED THE VICTIM AND A DESCRIPTION OF ANY WEAPON OR OBJECT
- 15 USED.
- 16 (viii) A CHECKLIST OF PHYSICAL ACTS THAT MAY HAVE OCCURRED
- 17 AND INSTRUCTIONS FOR THE PEACE OFFICER TO CHECK THE APPROPRIATE
- 18 BOXES. THE CHECKLIST SHALL INCLUDE SEXUAL ASSAULT, SEXUAL MOLES-
- 19 TATION, THROWING OBJECTS, PUSHING, SHOVING, GRABBING, SLAPPING,
- 20 KICKING, STRIKING WITH A CLOSED FIST, BITING, CHOKING, VERBAL
- 21 THREATS, THREATS WITH A WEAPON, AND SIMILAR ACTS THE BOARD CON-
- 22 SIDERS APPROPRIATE TO INCLUDE. SPACE SHALL BE INCLUDED FOR AN
- 23 ADDITIONAL BRIEF DESCRIPTION OF THE OCCURRENCE OR INCIDENT.
- 24 (F) THE FOLLOWING INFORMATION ABOUT ANY INJURIES THE VICTIM
- 25 SUSTAINED:
- 26 (i) A DESCRIPTION OF ALL INJURIES.

- 1 (ii) AN EXPLANATION OF WHETHER THE SUSPECT CAUSED THE
- 2 INJURIES.
- 3 (iii) IF THE VICTIM SOUGHT MEDICAL ATTENTION, INFORMATION
- 4 CONCERNING WHERE, HOW THE VICTIM WAS TRANSPORTED, WHETHER THE
- 5 VICTIM WAS ADMITTED TO A HOSPITAL OR CLINIC FOR TREATMENT, AND
- 6 THE NAME OF THE ATTENDING PHYSICIAN.
- 7 (G) THE FOLLOWING INFORMATION ABOUT ANY PROPERTY DAMAGE EVI-
- 8 DENT AT THE SCENE:
- 9 (i) A DESCRIPTION AND ESTIMATE OF THE DAMAGE.
- 10 (ii) THE NAME, ADDRESS, AND PHONE NUMBER OF ANY OWNER OF
- 11 DAMAGED PROPERTY.
- 12 (H) INFORMATION ABOUT WHETHER THE SUSPECT HAS PHYSICALLY
- 13 ASSAULTED THE VICTIM BEFORE, INCLUDING THE DATE AND THE NAME,
- 14 ADDRESS, PHONE NUMBER, AND OTHER RELEVANT INFORMATION ABOUT ANY
- 15 WITNESS TO THE PREVIOUS ASSAULT.
- 16 (I) INFORMATION ABOUT WHETHER THE SUSPECT HAD MADE PREVIOUS
- 17 STATEMENTS OR THREATS, INCLUDING THE CONTENTS OF THE STATEMENTS
- 18 OR THREATS, TO WHOM THEY WERE MADE, AND RELEVANT INFORMATION
- 19 ABOUT ANY WITNESS TO THE STATEMENTS OR THREATS.
- 20 (J) THE DATE AND TIME OF THE REPORT, AND THE NAME, BADGE
- 21 NUMBER, AND SIGNATURE OF THE PEACE OFFICER COMPLETING THE
- 22 REPORT.
- 23 (5) THE DOMESTIC VIOLENCE REPORTING FORM SHALL CONTAIN A
- 24 SECTION FOR THE VICTIM TO COMPLETE, INCLUDING ALL OF THE
- 25 FOLLOWING:

- 1 (A) FRONT AND BACK DIAGRAMS OF A GENDERLESS HUMAN FIGURE
- 2 WITH INSTRUCTIONS FOR THE VICTIM TO MARK ON THE DIAGRAMS WHERE HE
- 3 OR SHE WAS STRUCK OR INJURED.
- 4 (B) THE FOLLOWING STATEMENTS WITH "YES" OR "NO" BOXES TO BE
- 5 CHECKED BY THE VICTIM OR PEACE OFFICER, AS APPLICABLE:
- 6 I HAVE PHYSICALLY POINTED OUT TO THE [APPROPRIATE DESIG-
- 7 NATION OF PEACE OFFICER] WHERE I WAS STRUCK.
- 8 I HAVE ALSO INDICATED ON THE DIAGRAM WHERE I WAS
- 9 STRUCK.
- 10 I WAS ABLE TO POINT OUT TO THE [APPROPRIATE DESIGNATION
- of peace officer; the person who struck me.
- 12 I HAVE POINTED OUT TO THE [APPROPRIATE DESIGNATION OF
- 13 PEACE OFFICER] THE OBJECT USED TO STRIKE ME.
- 14 I UNDERSTAND ALL THE QUESTIONS.
- 15 COMPLETED BY [APPROPRIATE DESIGNATION OF PEACE OFFICER]
- 16 BECAUSE VICTIM UNABLE.
- 17 READ TO THE VICTIM BY BECAUSE VICTIM UNABLE.
- 18 (C) THE STATEMENT "I HAVE READ THIS REPORT OR HAD IT READ TO
- 19 ME AND AFFIRM THAT THE INFORMATION IS TRUE AND CORRECT" ABOVE
- 20 SPACES FOR THE VICTIM'S SIGNATURE AND DATE.
- 21 (D) ANY OTHER INFORMATION THE BOARD CONSIDERS APPROPRIATE
- 22 FOR THE SECTION TO BE COMPLETED BY THE VICTIM.
- 23 (6) THE DOMESTIC VIOLENCE REPORTING FORM SHALL CONTAIN THE
- 24 STATEMENT REQUIRED BY SECTION 15C OF CHAPTER IV OF THE CODE OF
- 25 CRIMINAL PROCEDURE, ACT NO. 175 OF THE PUBLIC ACTS OF 1927.
- 26 (7) THE DOMESTIC VIOLENCE REPORTING FORM SHALL HAVE
- 27 APPROPRIATE CAPTIONS, QUESTIONS, AND SPACE TO RECORD ANY OTHER

- 1 INFORMATION THE BOARD CONSIDERS APPROPRIATE TO AID IN THE
- 2 INVESTIGATION, ENFORCEMENT, AND PROSECUTION OF DOMESTIC VIOLENCE
- 3 AND SIMILAR CRIMES AND SHALL PROVIDE TO THE VICTIM ANY OTHER
- 4 INFORMATION THE BOARD CONSIDERS APPROPRIATE FOR THESE PURPOSES.
